

## National Highways & Infrastructure Development Corporation Ltd

2<sup>nd</sup> Minutes of Meetings dated 18.06.2018 of Empowered Technical Bid Evaluation Committee (ETEC) for Consultancy Services for Feasibility Study, Preparation of Detailed Project Report and providing pre-construction services for up gradation of newly declared National Highway, Tharthri-Kahaljugasar-Kilhotran (70 km, District- Doda, J&K) to Makhn-Chachool (10 km, District- Chamba, Himachal Pradesh) to 2-lane with paved shoulder including Feasibility study cum DPR of Tunnel of approx. length 4 km near Kahaljugasar in the state of Jammu and Kashmir

The bids for subject project were invited from the prospective bidders with submission date being 09.05.2018 till 1500 hrs.

2. The following firms had uploaded their bids on the CPP Portal by due date and time.

(i)	M/s RODIC Consultants Pvt. Ltd. In JV with M/s TPF GETINSA EUROESTUDIOS S.L.
(ii)	M/s Almondz Global Infra Consultant Ltd. In JV with Subterra Ingenieria S.L
(iii)	M/s Kunhwa Engineering & Consulting Co. Ltd In association with Satvig Survey Engineers Private Limited

3. During the 1st Meeting of ETEC, the Committee examined the general responsiveness and proof of eligibility. On the basis of that, the Committee recommended that, the firm M/s Almondz Global Infra Consultant Ltd. In JV with Subterra Ingenieria S.L failed to fulfill the minimum eligibility criteria mentioned and the result were uploaded on the NHIDCL website regarding eligibility/non eligibility.

4. M/s Almondz Global Infra Consultant Ltd in JV with Subterra Ingenieria S.L. submitted its representation claiming that there are more eligible projects which, have not been considered while examining for the proof of eligibility and submitted the its eligible projects according to its assessment.

5. ETEC met to evaluate the submission of the firm and noted that only eligible projects in terms of the provisions of RFP have been considered and no eligible projects was left out of the consideration and that the evaluation carried was strictly in terms of the condition of the RFP. 5.1 Committee further noted that the project at sr. no 45 (*Appointment of Consultant for preparation of Detailed Project Report for Construction of Road, Tunnel, Viaduct and Churhat Bypass of rewa-Sidhi Section of NH-75E from Km 33/200 to Km 55/400*) was accompanied with the LOA and no completion certificate was found



submitted as per the moved data. The firm has since submitted the completion certificate and also clarified as under.

*" We would like to clarify that the project "Consultant for preparation of Detailed Project Report for Construction of Road, Tunnel, Viaduct and Churhat Bypass of Rewa-Sidhi Section of NH-75E from Km 33/200 to Km 55/400" in the state of Madhya Pradesh" was awarded by Madhya Pradesh Road development Corporation Ltd to M/s Amberg Engineering AG India in JV with M/s Almondz Global Infra Consultant Ltd vide letter no. MPRDC/DPR/R-S/NH-75E/2015/1318 dated 29<sup>th</sup> April 2015. After the commencement of the DPR activates the project was transferred to National Highways Authority of India. Project Director, Katni was nominated as the nodal officer of the project. On completion of the project the Nodal Officer issued the experience certificate vide letter no NHAI/PIU/Katni/NH-75E/Churhat Bypass/Certificate /2017/196 dated 25<sup>th</sup> May 2017"*


6. In view of above, the committee decided to consider the project mention at sr. no. 45 as eligible project for a length of 15.35 Km. since the project was executed as associate partner, the weightage length attributed to the consultant is 25 % of the length i.e. 3.85. Thus the total aggregate length becomes 82.83 Km which is more than the required aggregate length of 80Km. Hence the firm qualifies for next stage of bidding process.


7. The committee thus recommended that all the bidders are qualified for 2<sup>nd</sup> stage evaluation in terms of the provisions of RFP. The committee recommended that the revised list of eligible bidder be communicated through website with the approval of Competent Authority:
