3nd Minutes of Meetings dated 06.07.2018 of Empowered Technical Bid Evaluation Committee (ETEC) for Consultancy Services for Feasibility Study, Preparation of Detailed Project Report and providing pre-Construction Services for up gradation of newly declared National Highway, Tharthri-Kahaljugasar-Kilhotran (70 km, District- Doda, J&K) to Makhan-Chachool (10 km, District- Chamba, Himachal Pradesh) to 2-lane with paved shoulder including Feasibility study cum DPR of Tunnel of approx. length 4 km near Kahaljugasar in the state of Jammu and Kashmir.

The bids for subject project were invited from the prospective bidders with submission date being 09.05.2018 till 1500 hrs.

2. The following firms had uploaded their bids on the CPP Portal by due date and time.

- 3. The committee noted that all the bidders who had submitted their bid by due date and time are eligible for the technical evaluation of their bid i.e. 2^{nd} stage evaluation.
- The committee then carried out the evaluation of the three bids. The ETEC noted that the key professional of M/s Almondz Global Infra Consultant Ltd. in JV with Subterra Ingenieria S.L, Mr. Bharat Sharma proposed for the position of Material cum Geotechnical Engineer has not uploaded properly the certificates pertaining to Graduation and Post graduation & could not be open. The Committee granted zero marks to Mr. Bharat Sharma. ETEC also noted that the Key personnel of M/s Rodic Consultants Pvt. Ltd. in JV with M/s TPF Getinsa Euroestudios S.L., Mr. Marcelo Usabiago Lasa (Tunnel Design Expert) has uploaded his master's degree in Civil Engineering but has not uploaded the Bachelor Degree in Civil Engineering. However the committee considered his master degree in civil engineering subject to submission of degree certificate, hence marks are given. Further in respect of proposal of M/s Kunhwa Engineering & Consulting Co. Ltd In association with Satvig Survey Engineers Private Limited, Tunnel Design Engineer Mr. Kim Young Geun has not filled the experience on Infracon prior to 2013 and failed to pass on account of its total professional experience being as 3.45 year. The details of the evaluation is placed at Annexure-I.
- 5. The Committee observed that all the firms are technically qualified in terms of provisions of RFP subject to fulfillment of para 4 above. The Committee noted the marks scored by the individual firm as under:
