

National Highways & Infrastructure Development Corporation Ltd

1st Minutes of Meetings dated 01.06.2018 of Empowered Technical Bid Evaluation Committee (ETEC) for Consultancy Services for Feasibility Study, Preparation of Detailed Project Report and providing pre-construction services for up gradation of newly declared National Highway, Tharthri-Kahaljugasar-Kilhotran (70 km, District- Doda, J&K) to Makhan-Chachool (10 km, District- Chamba, Himachal Pradesh) to 2-lane with paved shoulder including Feasibility study cum DPR of Tunnel of approx. length 4 km near Kahaljugasar in the state of Jammu and Kashmir

The bids for subject project were invited from the prospective bidders with submission date being 09.05.2018 till 1500 hrs.

2. The following firms had uploaded their bids on the CPP Portal by due date and time.

(i)	M/s RODIC Consultants Pvt. Ltd. In JV with M/s TPF GETINSA EUROESTUDIOS S.L.
(ii)	M/s Almondz Global Infra Consultant Ltd. In JV with Subterra Ingenieria S.L
(iii)	M/s Kunhwa Engineering & Consulting Co. Ltd In association with Satvig Survey Engineers Private Limited

3. ETEC was appraised that as per RFP, the proposals were received through the INFRACON Portal since the evaluation of the proposals through INFRACON was not possible since the project also involves preparation of DPR for a Tunnel.

4. Having opened bids on 10.05.2018, the committee met on 01.06.2018 to evaluate the proposals in accordance with the provisions of RFP. The proposals were evaluated for the 1st stage i.e. eligibility requirements. It was observed that M/s Almondz Global Infra Consultant Ltd. In JV with Subterra Ingenieria S.L has failed to pass the minimum eligibility criteria. The lead partner M/s Almondz Global Infra Consultant Ltd does not possess the requisite experience in the preparation of DPR of Road Projects. The remaining two proposals have qualified the first stage i.e. both the firms possess the essential eligibility requirements. The Detail is placed at **Annexure-A**.


