

General information to Quotations

- 1. The Total Amount quoted in words shall be the sole guiding factor for financial evaluation of Bidders.
- 2. Annexure 'A' for terms & conditions shall be the part of bid and hence shall be duly signed by the Bidder and submitted along with quotation.
- 3. Copy of document as per Cl.2 under Term and Conditions is to be submitted along with quotations and in case declared to be L-1 bidder original document has to be produced for verification before issuance of LOA.
- 4. Machine shall be operating with Sikkim.
- 5. Annexure-B & Annexure-C,D,E to be submitted along with quotation in sealed envelop
- 6. Cost of Document:- Rs 500/- in the form of DD in favour of Executive Director (P), NHIDCL payable at Gangtok. (Non-Refundable)
- 7. Out of responsive bidders lowest of all shall be considered declared as preferred Bidder i.e. L-1.
- 8. Rate to be quoted in form provided at Annexure-D, duly signed is to be submitted with quotation in sealed envelop.

ANNEXURE-'A' TERMS AND CONDITIONS

- Proposals are invited from reputed Agency/Contractor who has experience of highways construction or Maintenance work and can provide the Machines as mentioned above in bill of quantity to Project Monitoring Unit(PMU) Office at Gangtok (Sikkim), NHIDCL as detailed in BOQ on hourly basis.
- 2. The Machines should be in good condition. The self-attested copy of the registration certificate as well as insurance certificate and copy of the purchase document or lease document should be submitted along with the Quotations.
- 3. All necessary taxes and pollution certificate for operating the Machines should be valid upto oct 2020 and which shall be extended till services rendered to NHIDCL and the fee towards the same shall be fully paid by Agency/Contractor and all necessary papers shall be provided in the Machines as required by prevailing Motor Machines Act with comprehensive the Machines. Αll the related insurance coverage for cases to accident/damages/compensation shall be the responsibility of Machines Owner/ Agency/Contractor.
- **4.** The Machines shall be available day and night (24 hours) as required by Project Monitoring Unit (PMU) Office at Gangtok (Sikkim), NHIDCL.
- 5. The Agency/Contractor shall bear all expenses required for keeping the Machines in smooth running condition such as fuel, lubrications oil & other consumables, necessary service & maintenance, repairs & replacement etc. and salary of the driver per month & his related expenses for duty.
- 6. In the event of any Machines being off the site for maintenance or on any account of breakdown, the Agency/Contractor shall provide a substitute Machines immediately. If Agency/Contractor fails to do so at any point of time, Project Monitoring Unit(PMU) Office at Gangtok (Sikkim), NHIDCL is free to get work done at risk and cost of the contractor.
- 7. The quoted rates shall be inclusive of all taxes but excluding GST.
- **8.** The Agency/Contractor should submit their bills in duplicate/original along with logbook and photographic record within 1st week of every month for payment if any.
- **9.** The quoted rates shall be valid for contract period. Variation/revision in quoted rates on account of any increase in fuel or spares cost/maintenance/insurance/driver salary will not be entertained during the contract period.
- **10.** L-1 bidder has to submit performance security of 10% of quoted rate in form of bank guarantee with in 7 days form the issuing of LOA. However, bidder may submit performance security of 5% of quoted rate in form of bank guarantee and remaining 5% may be retained from every bill which may be returned after completion of contract period, based on satisfactory performance of work in contract period.
- **11.** The Agency/Contractor should be able to supply the required Machines within seven days from the date of Letter of Acceptance.
- **12.** An affidavit on a Stamp Paper, duly attested from the Notary Public, that the information furnished with the quotation documents is correct in all respects.
- 13. NHIDCL reserves full rights to curtail, modify, halt/cancel, reject any or all offer/s, at any stage without assigning any reasons and no claims of whatsoever nature will be entertained on this account.
- **14.** The supply of Machines is initially for duration of contract period only from the date of agreement. Machines may be continued beyond the stipulated period on the rates quoted & condition herein if required by NHIDCL and agreed by the bidder.
- 15. Bid/ quotation shall remain valid for period of 120 days from bid/ quotation due date
- 16. Insurance
 - 15.1 The Contractor at his cost shall provide, in the joint names of the Employer and the Contractor, insurance cover from the Start Date to the end of Contract period for events (a) to (d), in the amounts and deductibles stated in the Contract Data for the following events

which are due to the Contractor's risks:

- a) loss of or damage to the Works, Plant and Materials; i.e. Rupees equivalent to Contract price.
- b) loss of or damage to Equipment; i.e. Rupees equivalent to 5% of Contract price.
- c) loss of or damage to property (except the Works, Plant, Materials, and Equipment)
- in connection with the Contract; i.e. Rupees 20 lakhs for multiple incidents.
- d) Personal injury or death, i.e. Insurance policies should be as per work order basis.
- e) Insurance policies should be as per work order basis
- 15.2 Insurance policies and certificates for insurance shall be delivered by the Contractor to Project Monitoring Unit(PMU) Office at Gangtok (Sikkim), NHIDCL before the Start Date. All such

insurance shall provide for compensation to be payable in Indian Rupees to rectify the loss or damage incurred.

- 15.3 Alterations to the terms of insurance shall not be made without the approval of the Engineer.
- 15.4 Both parties shall comply with any conditions of the insurance policies.

17. Precautions for Safeguarding the Environment

The Contractor shall preserve existing trees, plants and other vegetation that are to remain within or adjacent to the works and shall use every precaution necessary to prevent damage or injury thereto. On completion of the Works, all areas disturbed by the Contractor's construction activities s hall be restored in their original condition, or as may be acceptable to the Engineer. The cost of this work shall be deemed to be included in the rates generally.

18. Plant and Equipment

During the day, plant and equipment working in a position adjacent to traffic and having a projection beyond the normal width of the item, for example, a grader blade shall have a fluorescent red marker attached to the outer end of the projection. During poor light conditions an additional traffic controller with an illuminated red marker shall direct traffic around such plant and equipment. At night, all plant items and similar obstructions shall be removed from the normal path of Machines, to provide a lateral clearance of at least 6m where practicable, with a minimum clearance of 1.2m.

Plant and equipment, within 6m of the normal path of Machines, shall be lit by not less than two yellow steady lamps suspended vertically from the point of the obstruction nearest to a traffic lane, and one yellow steady lamps at each end of the obstruction on the side farthest away from the traffic lane.
