National Highways & Infrastructure Development Corporation Limited (NHIDCL) has been entrusted with the development of the selected stretches/corridors of National Highways in the country on EPC mode. NHIDCL now intends to short-list eligible consulting firms/ companies/ Joint Ventures who have proven experience for Independent Construction Supervision on BOT/ EPC/ Public Funded Projects to act as Authority's Engineer (AE). In order to carry out the implementation of above projects as per Standard EPC document, NHIDCL will engage eligible Consulting Engineering firms/ Companies/ Joint Ventures to act as Authority's Engineer.

- 2. As per the terms and conditions of the Standard EPC Contract Agreement, the Authority's Engineer is required, on behalf of NHIDCL, to (i) review activities associated with design, design review, construction and operation & maintenance of the project to ensure compliance of requirements of Standard EPC Contract Agreement, (ii) report to NHIDCL on the financial and technical aspects of the projects, (iii) assist the parties to the Contract Agreement in arriving at an amicable settlement of disputes, if any.
- **3.** Engineering Services are to be provided by an integrated multi-disciplinary team of Key-Personnel consisting of Team Leader cum Sr. Highway Engineer, Senior Slope/ Safety Engineer, Sr. Contract Specialist, Resident Engineer cum Highway Engineer / Safety Manager, Bridge/Structural Engineer, Material Engineer, Sr. Quantity Surveyor, Environmental Expert, etc.
- 4. The total time period for the assignment as Authority's Engineer for **each** consultancy package shall be for Construction Period of 42 months and Maintenance Period of 48 months with reduced man power.
- 5. Instructions for submission of the expression of interest are enclosed at **Annexure-I** and guidelines for the preparation for the expression of interest is enclosed at **Annexure-II**. Eligible Consulting Engineering firms/Joint Ventures interested in short-listing for Authority's Engineer should fill up the enclosed expression of interest form (**Annexure-III**).
- 6. The sole applicant/members of Joint Venture (JV) should have experience as specified in Annexure-IV. Experience of project supervision in projects that have been substantially completed (not less than 90% of Contract value) shall be considered towards qualifying experience. For avoidance of doubt, it is clarified that those projects shall also be considered where the Provisional Completion Certificate for the project has been issued and the Authority/ Client has certified that the Project Highway has been safely put to the use of the road users.
- 7. Only those consultants who satisfy minimum eligible criteria need to apply. Client certificates shall be required for experience in both DPR and project Supervision. In case a Consulting Engineering firm claims experience for a project undertaken as a member of JV, the particular firm's position in the JV needs to be clearly brought out in the Client's certificate or in a supporting sheet by the firm itself. If the applicant firm has completed projects as JV with some other firms, weightage shall be given as per the JV share. In absence of clear demarcation of JV share in client certificate, the weightage will be treated as 60% for lead partner and 40% for other partner.

- **8.** The Authority shall evaluate the EOI proposals based on relevant experience of project monitoring, construction supervision, contract management, etc., in accordance with pre-determined criteria as detailed in LOI and thereupon shortlist 05 (five) qualified firms. The Short listing shall be done based on the marks obtained by the firm after evaluation of firm's experience, credential etc. The points assigned for evaluation criteria have been given in **Annexure-V**.
- 9. Detailed evaluation criteria which is to be used for evaluation of EOI proposals is as indicated at Annexure-VI. The Consultant shall also carryout self-evaluation based on the evaluation criteria at Annexure-VI. While submitting the self-evaluation along with proposal, the Consultant shall make references to the documents submitted in their proposal which have been relied upon in self-evaluation. Result of detailed evaluation shall be made available on the website giving opportunity to the applicants to respond within 7 days in case they have any objection. After resolving objections, if any, package wise list of shortlisted consultants shall be uploaded on website.
- 10. The Authority shall invite the aforesaid shortlisted consultancy firms through Request of Proposal (RFP) to submit their respective technical and financial bids, on e-tendering mode. All the technical bids so received shall be opened and pursuant to the evaluation thereof, the Authority shall declare the technically qualified firms on the basis of their technical scores. The financial bids in respect of such technically qualified firms shall be opened and the order of priority as among these firms shall be determined on the basis of a weighted evaluation where technical and financial scores shall be assigned respective weights of 80:20.
- 11. This is for information of willing Consultancy Firms and Key Personnel that Ministry of Road Transport & Highways (MoRT&H) has developed INFRACON Portal (<a href="www.infracon.nic.in">www.infracon.nic.in</a>) for uploading credentials/ experience details. It is therefore, requested that the Consultancy Firms/ Key Personnel may get registered on INFRACON Portal and upload their credentials/ experience on INFRACON. The firm in the EOI proposal shall be required to submit the name and INFRACON ID number of the Key Personnel mentioned at sr no. 8 of Annexure-III. It may please also be noted that at the RFP stage the experience/ credentials of the shortlisted Consultancy Firms in the Technical Proposal shall be required to be submitted through the INFRACON Portal. #### **INSTRUCTIONS FOR SUBMISSION OF EOI PROPOSAL**

- 1. The EOI document shall be the basis of drawing up a shortlist of Consultants who will submit proposals for the services required. The short listing of the Consultants shall be done separately for the consultancy packages mentioned in the Letter of Invitation.
- **2.** All applications shall be submitted in English.
- **3.** Power of Attorney (on stamp paper and duly notarized) of the person submitting the Expression of Interest on behalf of the applicant shall be attached.
- 4. A particular Consulting Engineering firm is allowed to be an eligible applicant provided it has applied either as a sole firm or in Joint Venture. In case of Joint Venture, the maximum number of Joint Venture partners is limited to 2 (i.e. one lead + 1 JV partners). In case of the application made by a Joint Venture, either Joint Venture MOU/Agreement or the Letter of Intent to form the Joint Venture shall be attached along with all necessary details. The Applicant whether a sole applicant or Joint Venture applicant may include an Associate company during RFP stage.
- 5. A Consulting Engineering firm may apply for one or more consultancy package(s) either as a sole applicant or as a member of Joint venture for different consultancy packages. Formulation of more than one JV with different partners for the same consultancy package is NOT allowed and all such Expression of Interest involving the firm shall be treated as non-responsive.
- 6. In case, if any firm, which is a 100% owned subsidiary company in India of a foreign company, claims the experience of the parent foreign company, an undertaking from the parent company is to be submitted with the proposal confirming thereby about perpetual and unconditional excess to expertise, personnel and facilities of the parent company to the firm, sharing of risks and profits of the firm by the Parent Company and that the parent company has majority representation in the management of the firm to control activities of the firm.

- 1. Indicate the consultancy package(s) for which the application (EOI proposal) is to be considered.
- 2. Complete name of firm, date of establishment and type of organization whether individual, proprietorship, partnership, private limited company, limited company, etc.
- 3. Name of affiliate firms, their years of establishment, countries of origin and type of organization.
- 4. Exact and complete home and office address, business address, telephone number, Fax number, Email and cable address. For consulting firms of foreign registry, indicate if there is any branch office(s) established in India with details in the aforesaid manner. Information is to be furnished by the sole applicant or members of JV individually.
