6. 8. For evaluation purpose, the consultant has taken limited projects fulfilling the minimum eligibility criteria and in calculation of value of B, the consultant has assumed that the projects have been not yet been started and the liability of bidder is 100 % for the project and thus the value of Bid Capacity does not increase, keeping it at a safer side.

9. **Recommendation of the Empowered Technical bid Evaluation Committee (ETEC):** The committee is of the view that all the six bidders are fulfilling the eligibility criteria prescribed in the RFP, therefore the financial bids of all the six bidders be opened with the approval of the Competent Authority.
