2nd Minutes of Meeting of Empowered Technical Bid Evaluation Committee (ETEC) to evaluate technical bids for "Construction of Hnathial bypass (Package-2) on Aizawl-Tuipang section of NH-54 in the State of Mizoram on Engineering, Procurement and Construction (EPC) mode, with Japan International Cooperation Agency (JICA) loan assistance".

Date: 17.07.2020 (11.00 AM)

Venue: 3rd Floor, PTI Building, NHIDCL, New Delhi.

The Member Secretary apprised the committee that Technical evaluation of the Eight firms was carried out on 20.05.2020 at 12:30 PM (Minutes of Meeting is attached as **Annexure-I**). The result of Technical Evaluation was uploaded on the CPP portal, NHIDCL website & BIMS Portal and the bidders were given an opportunity to offer their comments within 7 days from 10.07.2020. The financial proposal of bidders is planned to be opened on 17.07.2020 at 11:00 AM.

- 2. Comments have been received from two bidders i.e. M/s. Bhavya Construction and M/s. Sunshine Overseas Pvt. Ltd. within the stipulated time-frame.
- 3. Submissions made by the above mentioned bidders have been examined by the ETEC and the details are mentioned below:
- 3.1 M/s. Bhavya Construction: The bidder claimed all their 6 projects in Category-3 with total Experience Score of 100.53. As per clause 2.2.2.5 (iii) (II) of RFP, Periodic Renewal works are not considered as eligible projects. Hence, the projects at Project code 'B' & 'C' have not been considered. Projects at Project code 'D' & 'E' are IRQP works and considered in Category-4 as per clause 2.2.2.5 (iii) (III). Also, Projects at Project code 'A' does not fall under Category-3 and considered in Category-4 as per clause 2.2.2.5 (iii) (V). The project claimed at Project code 'F' is considered in Category-3 but the Experience score of 24.70 pertains to the FY 2019-20 and has been rejected in accordance with the para 1 & 4 of Annex-III (Financial Capacity of the Bidder) of Appendix-IA and clause 2.1.17 of RFP vide which the payments received till FY2018-19 is to be considered. Therefore, the total Experience Score has been reduced to 32.75 and the project claimed at S. No. 6 has not been considered as one single completed work of similar nature. Hence, the bidder does not meet the criteria required as per clause 2.2.2.2 (i) & (ii) and there is no change in the previous evaluation.
- 3.2 M/s. Sunshine Overseas Pvt. Ltd.: The bidder has incorrectly claimed all their 08 projects in Category-1 but as per clause 2.2.2.6 (i), Category-1 pertains to mainly PPP projects and the projects claimed by the bidder are maintenance and construction works on item rate or EPC. Hence, the category of each project and the experience score claimed by the bidder has been modified. The projects claimed by the bidder at Project code 'C','D','F' & 'H' has not been considered as eligible projects as per clause 2.2.2.6 (ii) amended vide Amendment No. 1 because the payments received in these projects during the 05 financial years from FY2014-15 to FY2018-19 (refer clause 2.1.17) is less than 7.15 Crore. Projects claimed at Project code 'B','G' (IRQP works) & 'E' has been considered in Category-4 as per clause 2.2.2.5 (iii) (III) & clause 2.2.2.5 (iiii) (V). IRQP works are not the original nature of works and as per clause 2.2.2.5 (iii)

(III), these works shall not be considered for single completed works i.e. under Category-1 or 3. Project at project code 'A' has been considered in Category-3 and as one single completed work of similar nature. Therefore, the total Experience Score has been reduced to 59.39. Hence, the bidder is not meeting the criteria as per clause 2.2.2.2 (i) and there is no change in the previous evaluation.
