D. We would like to mention that may projects of Box Pushing under North Central Railway, Northern Railway etc were executed by installing restricted height girder (RH Girder) or by installation of structural steel some structure under the running railway tracks as per the Northern drawing of Railway. After installation of such structure air pushing was done. In order to discourage participation of such superficial air projects pushing department may insert some clauses if it so desires. This may be taken as a suggestion if it benefits the department.
