Minutes of Meeting of Empowered Technical Bid Evaluation Committee (ETEC) to evaluate the Technical bids for Consultancy services as Authority's Engineer for Supervision of "Rehabilitation and Up-gradation to 2 lane with paved shoulders of Seling-Dulte section (Economic Corridor) of NH-6 from Existing chainage Km 0+000 to Km 69+015 (Design Chainage Km 0+000 to Km 62+200) in the State of Mizoram under Bharatmala Pariyojna on EPC mode".

Date: 08.06.2020 (11:00 AM)

Venue: PTI Building, 3rd Floor, Conference Hall, NHIDCL HQ, New Delhi.

1. Technical evaluation of the six firms was carried out on 19.05.2020 at 03:00 PM (Minutes of Meeting is attached as Annexure-I) and further on 05.06.2020 at 03:00 PM, based on the Representation received from M/s Technocrats Advisory Services Pvt. Ltd. in association with Jagadambike Infrastolution Private Limited within the stipulated time-frame i.e. upto 03:00 PM on 04.06.2020 (Minutes of Meeting is attached as Annexure-II). The Final scores of the firms in the technical evaluation were uploaded on the CPP portal & NHIDCL website. The financial bids are planned to be opened on 08.06.2020 at 11:00 AM.


2. However, one complain has been received through e-mail on 06.06.2020 against the opening of Financial Bids of M/s Ayoleeza Consultants Pvt. Ltd.- SOWIL Limited (JV) mentioning that the above firm has already 03 Consultancy Projects in NHIDCL as mentioned below:

(i) Consultancy services for Four laning from Biswanath Chariali to Gohpur from 208 to km 265.50 of NH52

(ii) Consultancy Services for Authority's Engineer for 4 laning from Km 278.600 (End of Nagoan Bypass) to Km 315.315 (Kaliabor Tiniali) of Nh-37 under SARDP-NE Phase-A in the State of Assam on EPC basis

(iii) Consultancy Services for Authority's Engineer for supervision of "Improvement /Widening to 2-laning of stretch from Khongsang to Tamenglong (Design Length=37.97 km) of NH-137 in the State of Manipur on EPC mode under SARDP-NE"

3. As per the clause 1.7 (e) of Section-2 of RFP, "No Consultancy firm will be awarded more than 03 (three) projects of Consultancy services as Authority's Engineer/Independent Engineer in NHIDCL. If any consultancy firm either as a sole bidder or as JV partner/Associate has already been awarded 03 consultancy projects as Authority's Engineer/Independent Engineer in NHIDCL, then that consultancy firm will not be eligible for bidding for this work. Consultancy firms who are H1 in any of the projects of Authority's Engineer/Independent Engineer under NHIDCL will be considered as awarded projects. Consultancy firms must submit an undertaking w.r.t. the above details in the specified format as per Appendix B-11."



4. The bidder M/s Ayoleeza Consultants Pvt. Ltd.- SOWIL Limited (JV) has provided the information of ongoing works in NHIDCL in Appendix-B11 only for the 02 projects as mentioned at para 2 (ii) & (iii) above and the bidder has not mentioned the details of the project at para 2 (i) i.e. Consultancy services for Four laning from Biswanath Chariali to Gohpur from 208 to km 265.50 of NH52 which is ongoing project in NHIDCL in the State of Assam and awarded to M/s STUP Consultants in association of M/s Ayoleeza Consultants Pvt. Ltd.


5. The final result of technical evaluation is as under:
