The scores of the firms in the technical evaluation were uploaded on the CPP portal & NHIDCL website and the bidders were given an opportunity to offer their comments by 04.06.2020 upto 03:00 PM. The financial bids are planned to be opened on 08.06.2020 at 11:00 AM.
- 2. One Representation has been received from M/s Technocrats Advisory Services Pvt. Ltd. in association with Jagadambike Infrasolution Private Limited within the stipulated time-frame.
- 3. Submissions made by the above mentioned bidder have been examined by the ETEC and the details are mentioned below:
- 3.1 Road Safety Expert (Mr. Yogesh V. K.): The bidder has claimed all projects from Sl. no. 1 to 35 for the qualification criteria under 2(ii) i.e. Experience in similar capacity in Road safety works on Major Highway Project (similar configuration (2/4/6 laning) and above). However, on examining the Experience Certificates/Self Declaration attached in each project on Infracon Portal, it is observed that the Key personnel has not worked in similar capacity i.e. Road Safety Expert in the projects from Sl. No. 1 to 31 and in project at Sl. No. 32, no Experience Certificate/Self Declaration is attached. Projects at Sl. No. 33, 34 & 35 has been considered having total period experience of 4 years & 5 months which is less than the required experience i.e. 5 years. Hence, there is no change in the earlier evaluation.
- Road Safety Expert (Mr. Yogesh V. K.): The bidder has claimed the projects at Sl. no. 12, 13, 17, 26, 31, 32, 33, 34 for the qualification criteria under 2(iii) i.e. Experience in similar capacity in Road Safety Audits of 2/4/6- laning Highway Projects at different stages including at least one at design stage. However, on examining the Experience Certificates/Self Declaration attached in each project on Infracon Portal, it is observed that the Key personnel has not worked in similar capacity i.e. Road Safety Expert in the projects at Sl. No. 12, 13, 17, 26, 32 and in project at Sl. No. 32, no Experience Certificate/Self Declaration is attached. Accordingly, 03 Projects at Sl. No. 33, 34 & 35 has been considered w.r.t. the required experience i.e. minimum 02 projects and maximum 04 projects for full marks. Hence, there is no change in the earlier evaluation.
