- 1. The vehicles should be in good running condition and well maintained. The interior of the vehicle should be neat and clean and A/C should be in working condition. There shall not be any lapse on crucial safety aspect, for which successful bidder will be solely responsible.
- 2. All necessary taxes for operating the vehicles commercially should be fully paid and all necessary papers shall be provided in the vehicle as required by prevailing Motor Vehicles Act with comprehensive insurance coverage for the vehicle and Pollution Control Certificate.
- 3. The vehicle shall be available day and night (24hours) as required by NHIDCL for all days regularly in a month with adequate fuel etc.
