## Minutes of Meeting

Construction and upgradation of existing road to 2-lane with paved shoulder of Bagrakot-Kafer section of NH-717A from Km. 26.100 to Km. 40.000 on EPC basis under SARDP-NE Phase 'Á' in the State of West Bengal (Package-IV D)- Minutes of Meeting of Empowered Financial Bid Evaluation Committee (EFEC) dated 20.03.2020 at 17:00 hrs.

Having opened the financial bids of technically responsive bidders online through CPP Portal by EFBC on 20.03.2020 at 15:00 hrs, the EFEC deliberated in its meeting on 20.03.2020 at 17:00 Hrs and observed that KCL-BBPL (JV) has quoted the lowest amount of Rs 177.99 Crore, which is 5.51% lower than the cost put to tender i.e. Rs. 188.38 Crore.

2. EFEC noted the financial quote of the bidders as under:

- 3. Further the EFEC was apprised that the Bid Price offered by the said Lowest Bidder i.e. KCL-BBPL (JV) is 5.51% lower as compared to Estimated Project Cost of the project i.e. Rs 188.38 Crore. Therefore, the requirement of providing Additional Performance Security as per clause 2.21.1 of the RFP document, is not applicable.
- 4. In view of the above, the EFEC recommended to declare KCL-BBPL (JV) as the 'Selected Bidder' in terms of clause 3.3.1 of RFP at its quoted price of Rs. 177,99,00,000/-inclusive of all taxes except GST.
