The bids for the subject work were invited on 03.11.2021 with Bid Due Date as 16.11.2021 with a completion period of 06 months. The bids were opened on 17.11.2021 at 12:30 Hrs in NHIDCL-RO Jammu. No representative of any bidders was present during the bid opening of the subject project.

2. The Technical Bid Opening Committee (TBC) has broadly determined the responsiveness of the bids with reference to BG/DD towards bid security, cost of documents and POA and deliberated that the following 02 nos. bids may be evaluated further for determination of technical responsiveness:
