

- iii) Pranay Goswami


3. The Evaluation Committee met together for evaluate all the bids. The committee after examining the technical bids, observed that all the 3 (three) bidders are fulfilling the evaluation criteria mentioned in RFP (details enclosed) and accordingly carried out the marking/score of all the three bidders for checking the technical competence as per Clause 3 of Section-6 of the RFP documents.
