6. The site for the work is available.
7. 8. To participate in bidding process, bidders have to get (DSC) “Digital Signature Certificate” as per Information Technology Act-2000, to participate in online bidding. This certificate will be required for digitally signing the bid. Bidder can get above mentioned digital

certificate from any approved vendors. The Bidder, who already possess valid (DSC) “Digital Signature Certificate” need not to procure new Digital Signature Certificate.

9. The bidders have to submit their bids online in electronic format with Digital Signature. The bid cannot be uploaded without Digital Signature.
10. Bids will be opened online as per time schedule mentioned at Sr. No. 18.
11. Before submission of online bids, bidder must ensure that scanned copy of all the necessary documents have been attached with bid.
12. The department will not be responsible for delay in online submission of bids whatsoever reasons may be.
13. All the required information for bid must be filled and submitted online.
14. Bidders should get ready with the scanned copies of cost of documents & Bid Security as specified in the tender documents. The original instruments in respect of cost of documents, Bid Security and relevant documents etc. may be submitted to the address mentioned in Sl. no. 7 by Registered post/courier/by hand in original on or before i.e., 21.02.2024 till 1500 hours and it should be pledged in the name of Executive Director, Regional Office-Agartala, Tripura.
15. The details of cost of documents, Bid Security specified in the tender documents should be the same, as submitted online (Scanned copies) otherwise bid will not be accepted.

- The works shall be carried out as per site condition. The work may be required to be fully executed, partially executed or may not be executed at all as per site condition and Engineer in charge direction and the project work will be foreclosed on fixing of appointed date of the upgradation work. Therefore, no claim whatsoever from any of the selected bidders on this account shall be entertained in this regard.
23. No Extension of Time shall be entertained in any circumstance.
24. Make in India- As per policy of Govt. of India to promote Make in India, the provisions vide order no. P-45021/2/2017-B. E-II dated 15.06.2017 on the subject “Public procurement (preference to Make in India)” shall be applicable to the extent possible.
25. The format of the BG will remain same as prescribed in the RFP. **However, No BG shall be accepted in the physical form.
