Notices have been given/are being given to the EPC contractors to fulfill their obligations as per the Contract Agreement. The bid invited by NHIDCL for Repair and Maintenance works and NIT is to carry out the repair and maintenance of the National Highways which are being 4 laned, in case the EPC contractors fail to carry out the repair and maintenance of existing highway and take necessary preventive action to ensure that the existing highway does not get damaged and remains in traffic worthy condition at all times. The repair and maintenance works for which bid has been invited shall accordingly be carried out on as required basis by placing of work order (s) as per site condition.
