General Terms and conditions of contract

- 1.The contract may be extended, on the same terms and conditions or with some addition/deletion/modification, for a further specific period mutually agreed upon by the successful service providing Company/Firm/Agency and National Highway and Infrastructure Development Corporation Limited., Itanagar Branch
- 2. The contracting Company/Firm/Agency shall not be allowed to transfer, assign, pledgeor sub-contract its rights and liabilities under this contract to any other agency withoutthe prior written consent of this Company.
- 3. The National Highway and Infrastructure Development Corporation Limited, Itanagar Branch at present, is in requirement of manpower on urgent basis. The requirement of the National Highway and Infrastructure Development Corporation Limited, Itanagar Branch may increase or decrease during the period of initial contract also and thebidder would have to provide additional manpower, if required on the same terms and conditions.
- 4. The bidder will be bound by the details furnished by him/her to the National Highway andInfrastructure Development Corporation Limited, Itanagar Branch while submitting thetender or at subsequent stage. In case, any document furnished by him/her is found tobe false at any stage, it would be deemed to be breach of terms of Contract makinghim/her liable for legal action besides termination of contract.

LEGAL

- 15. The tendering agency will be responsible for compliance of all statutory provisions relating to minimum wages, Service tax, Provident Fund and Employees StateInsurance etc., if applicable in respect of the persons deployed by it in the NationalHighway and Infrastructure Development Corporation Limited, Itanagar Branch.
- 16.
