2nd Minutes of Meeting of Empowered Technical Bid Evaluation Committee (ETEC) to evaluate technical bids for “Up-gradation to Two lane with Paved shoulder from Km. 12+850 to Km.20+300 of 7.450 Km. length on Goha-Khellenai section and a link road to Goha Village of 2.016 Km on NH-244 in Union Territory of Jammu & Kashmir on EPC mode”.

Member Secretary of the committee apprised that based on the recommendation of Empowered Technical Bid Evaluation Committee (ETEC) meeting held on 24.07.2020 certain clarifications were asked from the following bidders vide this office letter dated 24.07.2020 to furnished their replies till 27.07.2020 at 12:00PM., the bidders have since replied to the same. Note: There is difference in Applied Technical Threshold Capacity by the bidders and Assessed Technical Threshold Capacity as the bidders claimed their technical threshold capacity without applying the multiplying factor for the respective year (i.e. 1, 1.05, 1.10 so on and so forth) and in some cases, the bidder has claimed the project in different category i.e. Projects falling under Category 4 are claimed in category 3 by bidders.

- (viii) M/s Beigh Construction Company Pvt. Ltd


