#### **BID SECURITY**

- (c) In the case of a Successful Bidder if the Bidder fails to sign the Agreement

The Performance Security shall be refunded after the successful completion of the contract.

#### **TERMS AND CONDITIONS**

- 1. Vehicles shall be in good running condition.
- **2.** Proposals are invited from agencies/individuals who can provide vehicle as detailed in BOQ on monthly basis.
- **3.** Refilling of water shall be responsibility of the Agency. The quoted rate shall be inclusive of water.
- **4.** All necessary taxes for operating the vehicles commercially should be fully paid and all necessary papers shall be provided in the vehicle as required by prevailing Motor Vehicles Act with comprehensive insurance coverage for the vehicle. NHIDCL shall not be liable for any damages whatsoever to public property and /or any third person due to any accident arising out of and in the course of vehicles.
- **5.** The vehicles shall be available day and night (24 hours) as required by NHIDCL for all days regularly in a month.
- **6.** The driver should be in sound mental and physical condition.
- 7. The driver should be having valid driving licence.
- **8.** The Agency shall submit the following self-attested documents along with the acceptance letter:
  - i. Copy of GST Registration certificate
  - ii. Copy of PAN Card
  - iii. Copy of Registration Certificate of vehicles
  - iv. Copy of Full comprehensive Insurance to cover third party and occupants
  - v. Copy of PUC Certificate
  - vi. Copy of Fitness Certificate
  - vii. Copy of Permit for Commercial Operations
- **9.** The Agency shall bear all expenses required for keeping the vehicles in smooth running condition such as fuel, lubrications oil & other consumables, necessary service & maintenance, repairs & replacement etc. and salary of the driver per month.
- **10.** In the event of any vehicle being off the road for maintenance or on any account of breakdown, the Agency shall provide a substitute vehicle immediately. If the substitute vehicle is not provided penalty of Rs. 15,000/-per day for each vehicle shall be affected from the bills of Agency.
- **11.** The Agency should quote their rates on monthly basis.
- **12.** The Agency should ensure that sufficient fuel is always available in vehicles.
- **13.** The quoted rates shall be inclusive of taxes including of applicable GST.
- **14.** Vehicle/Vehicles can be withdrawn from usage within 15 (fifteen) days of advance notice by either party i.e. Agency or NHIDCL.

- **15.** The Agency should submit their bills in duplicate along with logbook within 1st week of every month for payment.
- **16.** The hire charges will be paid on the basis of joint records maintained by driver and Representative of NHIDCL. Log books shall be signed by Representative of NHIDCL on day to day basis.
- **17.** The quoted rates for hire charges of vehicles with fuel and lubricants etc. should be valid for period of Two months from the date of acceptance. No variation/revision in quoted rates on account of any increase in fuel or spares cost will be entertained.
- **18.** The Agency should be able to supply the required vehicles within 30 days from the date of Letter of Acceptance.
- **19.** The supply of vehicles is initially for duration of Two months only from the date of agreement. Vehicles may be continued beyond the stipulated period on the rates quoted & condition herein if required by NHIDCL and agreed by the bidder.
- 20. NHIDCL will in no way be responsible for violation of traffic rules and /or infringement of any other law for the time being in force, either by the driver of the vehicle or by the service provider. The driver as well as service provider shall comply with relevant rules and regulations of Motor Vehicles Act and Rules applicable at present or in future during the tenure of the contract and as may be enforced from time to time for which NHIDCL would not be held liable/responsible in any manner what- so-ever. Onus of compliance of all the applicable Laws/Acts/Rules including those under Motor Vehicle Acts/Rules shall rest with the Agency only and NHIDCL will not be liable in any manner.
- **21.** The Jurisdiction of vehicles moving is Nagaland and other North Eastern States.
