

## Minutes of Meeting of Empowered Technical Bid Evaluation Committee (ETEC)

**Date:** 27.02.2019 at NHIDCL, Branch Office- Jammu.

**Name of work:** Removal of loose strata/material lying on the hill slope by scaling at Km 83rd Drabshalla on Batote-Kishtwar road, NH-244 in District Kishtwar in the state of Jammu and Kashmir.

1. As per RFP, it is noted by ETEC that the minimum eligibility/qualification criteria are as under:

2. ETEC has examined the documents received from the bidders as per the requirement of RFP and the details are attached as Annexure-I.

3. The Committee observed the following points:

**3.1 M/s EIMSIM Baba's Infrastructure Pvt. Ltd., Company:**

3.1.1 ETEC examined the documents submitted by the bidder on CPP Portal as well as in hard copy.

3.1.2 It is found that the experience certificate submitted by the contractor does not qualify for the similar nature of work as required as per clause 4.4 (b) of RFP.

3.1.3 Also, bid capacity calculated by the contractor is incorrect as the same has been calculated on 24.11.2017.

3.1.4 Hence, in view of above, the bidder is not technically eligible.

**3.2 M/s Jai Buildcon Pvt. Ltd., Company:**

3.2.1 ETEC examined the documents submitted by the bidder on CPP Portal as well as in hard copy.

3.2.2 The bidder has uploaded the copy of registration of firm but the hard copy of the same was not submitted and the bidder has provided a copy of PAN Card which is not clearly visible.

3.2.3 The bidder has only uploaded the copies of ITR for last two years only (hard copies of the same were not submitted) but the same is not as per clause 4.2 of RFP.

3.2.4 It is found that the bid capacity calculated by the contractor is incorrect and the certificate from Chartered Accountant as a proof of turnover for the last five years was not submitted.

3.2.5 The experience certificate submitted by the contractor does not qualify for the similar nature of work as required as per clause 4.4 (b) of RFP.

3.2.6 Also, the line of credit and availability of financial resources certified by bankers was uploaded by the contractor but the same was not submitted by the bidder in hard copy.

3.2.7 Hence, in view of above, the bidder is not technically eligible.

**3.3 M/s Mohd. Maqbool Butt, Proprietorship Firm:**

3.3.1 ETEC examined the documents submitted by the bidder on CPP Portal as well as in hard copy.

3.3.2 The bidder has uploaded CV of technical personnel but the same was not provided in the hard copy.

3.3.3 Undertaking of investing cash upto 25% of value of work & for bid validity period of 120 days has been submitted on letter head but the same needs to be submitted on stamp paper duly notarised.

3.3.4 The experience certificate submitted by the contractor includes clearance of landslides in ordinary rock & hard rock which may be qualify for the similar nature of work as per clause 4.4 (b) of RFP subject to the condition that the clarification from the department issuing certificate may be sought whether the clearance of landslide include the controlled surface blasting or not.

3.3.5 Hence, in view of above, the bidder is eligible subject to the above clarification.

**3.4 M/s Rakesh Kumar Chowdhary, Proprietorship Firm:**

3.4.1 ETEC examined the documents submitted by the bidder on CPP Portal as well as in hard copy.

3.4.2 It is found that the copy of Registration under Provident fund as per RFP was not submitted and also the copy of affidavits of investing cash upto 25% of value of work & for bid validity period of 120 days have not been notarised as per RFP.

3.4.3 The bidder does not have minimum required bid capacity as per clause 4.6 of Section 2 of ITB of RFP.

3.4.4 Also, the experience certificate submitted by the contractor does not qualify for the similar nature of work as per clause 4.4 (b) of RFP.

3.4.5 Hence, in view of above, the bidder is not technically eligible.

4. The ETEC observed the following regarding the qualification of each bidder:
