Subject:- Construction of Foot Track from Basam to Tathi from KM 0.000 to KM 32.060 in Upper Subansiri Valley District of the state of Arunachal Pradesh on EPC Mode.

It is to inform all the bidders of the subject work, the following:-

- (a) Road Mipi-Mathum (Basam) is under construction by NHIDCL as ICBR Road which work has commenced and will take approx 18 months to complete.
- (b) Start point of the foot track is Basam and end point is Tathi and are in high Altitude Area of approx 11000 to 12000 feet. As of now Basam is not connected by any other means except a foot track from Mipi which is used by ITBP personnel for their movement.
- (c) The vehicle /Equipment /Plant can reach Basam for commencement for foot track work by using Porters & Ponies.
- (d) The existing track is not maintained well for sustained movement. Existing trail/track can be used for induction of labour /stores and major effort will be required for its improvement.
- (e) All prospective bidders are required to note the above and asses the requirement of work before submitting their bids.
