Having opened the financial bids of technically responsive bidders online through CPP Portal by EFBC on 24.03.2020 at 15:00 hrs, the financial bid has been evaluated and report is being submitted accordingly.

- 3. The Empowered Financial Evaluation Committee (EFEC) discussed in detail the financial bids of the technically responsive bidders and observed as under:
 - i. The bid price Rs. 88,90,00,000/- (Rupees Eighty eight crore ninety lakh only) quoted by M/s ASC Infratech Pvt Ltd (which is 7.65% below) than the estimated cost of Rs 96.26 crore is the lowest quote among all the bidders. Therefore, the same is the lowest bidder as per clause 1.2.6 of the RFP and is recommended as selected bidder as per clause 3.3.1 of the RFP.
 - ii. The Committee further observed that the bid price of the selected bidder i.e M/s ASC Infratech Pvt Ltd is lower by less than 10% with respect to the estimated project cost (i.e Rs. 96.26 Cr.). The bidder shall furnish only performance security of 5% as per clause 2.21.1 of the RFP.

- iii. The selected bidder M/s ASC Infratech Pvt Ltd has to furnish a performance security of 5% amounting to Rs. 4,45,00,000/- (Rupees Four Crore forty five lakh only)
- It was brought to the notice of the committee that AA&FS of the subject project under number - A-12025/8/2019/Tri-NHIDCL Cell dated 03.03.2020 having a total project cost of Rs. 178.43 Cr has been obtained.
- 5. Committee, after deliberation, recommended to award the work to selected bidder i.e M/s ASC Infratech Pvt Ltd at the quoted price of 88,90,00,000/- (Rupees Eighty eight crore ninety lakh only) with performance Bank Guarantee of Rs. 4,45,00,000/- (Rupees Four Crore forty five lakh only) after approval of Competent Authority
