- 1. The bids for the subject work were invited and 5 bids were physically received on scheduled bid due date on 16.03.2020.
- 2. Empowered Technical Bid Opening Committee (ETBC) met to open the technical Bids on 17.03.2020 at 1100 hrs. The following bidders have submitted their bids physically and online.

 - (v) M/s KKB-Shanti (JV)
- 3. It is to brought to the notice of the committee that that M/s SRK Constructions and Projects Private Limited had submitted the bids physically at 1150 Hours on 16.03.2020 against 1100 Hours on 16.03.2020 as per RFP. M/s SRK Constructions and Projects Private Limited vide letter dated 16.03.2020 had requested that their bid may be accepted as the delay was due to late arrival of the flight and they have already uploaded the bid online. Competent Authority's approval was obtained to accept the bid of M/s SRK Constructions and Projects Private Limited so as to increase the competitiveness of the bid.
- 4. It is to mention that the M/s KKB-Shanti (JV) has not uploaded the bid on BIMS portal. However, the bid of M/s KKB-Shanti (JV)is also recommended for further technical and financial evaluation as there is initial teething issue with the software which is being constantly upgraded and till this is resolved, all such bids is recommend for acceptance..
- 5. It is also to mention that the BIMS portal has declared all the bids as technically non-responsive. However, due to the initial teething issue it is recommended to evaluate the bids manually as was being done before introduction of BIMS.
