2. Thereafter, you are required to execute contract Agreement in accordance with clause 3.3.5 within 15 (Fifteen) days from the date of issue of LOA as per Clause 1.3 of RFP.

3. Further, as per RFP documents, the contractor for due and faithful performance of its obligations during the Construction period as well as Defects Liability Period, shall furnish a Performance Security by way of an irrevocable and Unconditional Bank Guarantee in accordance with clause 7.1.1 of Article 7 of Contract Agreement within 10 days from signing of

the Contract Agreement. As per the Article 7 of DCA, you have to furnish a Performance Security of 5% of the amount quoted by you amounting to **Rs 5,25,00,000/- (Rupees Five Crore Twenty Five Lakh Only)** and Additional Performance Security of **Rs 27,42,000 (Rupees Twenty Seven Lakh Forty Two Thousand Only)**. The Performance Security shall be valid until 60(Sixty) days after the Defect Liability Period, whereas the Additional Performance Security shall be valid until 28 (twenty eight) days after the issue of Completion Certificate under Article 12 of the DCA.

4. You are required to comply with all terms and conditions set forth in the RFP & DCA documents. In case of any default on your part, you shall be liable for action as stated in the RFP & DCA documents.

5.
