Minutes of Meeting of Empowered Technical Bid Evaluation Committee (ETEC) on 10.08.2020 to evaluate the Technical bids for Consultancy services for Authority's Engineer for Supervision of:

(i) Construction of two lane with hard shoulder of Kohima-Jessami Road on NH-29 (Old NH-150) from existing km 76.320 (near Mesulumi Village) to existing km 98.380 (near Chizami Village) [Design Length - 22.06 Km] in the state of Nagaland Under Bharatmala Pariyojana on EPC Mode (Package IV)

(ii) Construction of two lane with hard shoulder of Kohima-Jessami Road on NH-29 (Old NH-150) from existing km 98.380 (near Chizami Village) to existing km 120.367 (Nagaland/Manipur Border) [Design Km 95.700 to Design Km 117.200] [Design Length - 21.500 Km] in the state of Nagaland Under Bharatmala Pariyojana on EPC Mode (Package V)

1. ETBC had opened the Technical bids on 23.06.2020. Empowered Technical Bid Evaluation Committee (ETEC) met on 25.07.2020 to evaluate the proposals as per the terms of RFP document.

2. In its First meeting, the committee had observed that the participating firms as mentioned above in Para 2(b) are technically qualified in terms of provisions of RFP. The Technical score of the firms awarded are as under :

3. ETEC during its first evaluation had found that the bid submitted by the M/s Planning & Infrastructural Development Consultants Pvt. Ltd was missing USIN number. Accordingly, the same was advised to be submitted by the bidder. M/s Planning & Infrastructural Development Consultants Pvt. Ltd vide

letter no. PIDCPL/NHIDCL/AE/2020-21/Nagaland/569 dated 08.08.2020 have submitted the requisite document along with UDIN No. and the same is acceptable.

4. Further, ETEC had decided to ask the bidders to submit their comments within 7 days i.e. 07.08.2020 as per Clause 10 (vii) data sheet of RFP. However, no comments were received.

5. It was brought to the notice of the committee that M/s Arkitechno- G Eng Advisory Services Private Limited (JV) has already been awarded 3 projects and the details are follows:

6. Clause 23 regarding the Participation of Consultant in bidding process of NHIDCL states that

The bidder either as individual firm or in JV or in association, who are having (three) or more on – going Authority's Engineer Consultancy Contract(s) in NHIDCL, as on date of bid submission, shall not be eligible to bid for this Authority's Engineer Consultancy Contract (Issuance of LOA will be considered as an on-going Authority's Engineer Consultancy contracts).

AND

The bidder shall not be awarded more than 3 (three) Authority's Engineer Consultancy Contracts for current bidding process in NHIDCL

7. Since as per clause 23 of the RFP, any bidder either as individual firm or in JV or in association cannot be awarded more than 3 projects, the technical bid of M/s Marc Technocrats Private Limited- M/s G Eng Advisory Services Private Limited (JV) is rendered Technically non responsive.
