Minutes of Meeting of Empowered Technical Bid Evaluation Committee (ETEC)

Date: 03.07.2018 at NHIDCL (HQ).

Name of work: Up-gradation to 4-lane with Paved Shoulder of Jammu-Akhnoor road section of NH-144A from Ganesh Vihar (Km 6.000) to Hanuman Chowk (Km 30.000) of 24 Km length in the state of Jammu and Kashmir to be executed on EPC basis.(Pkg-III).

Having opened the technical bid on 20.06.2018 by ETBC, the bid was handed over to the financial consultant for further evaluation in terms of clause 3.1.6, 2.2.2.2 and 2.2.2.3 of the RFP. The financial consultant M/s Indraprastha Corridor Advisory Services vide its letter no. NHIDCL/2017/Jammu-Akhnoor/EPC/4448 dated 22.06.2018 submitted the evaluation report (Annexure-I) in terms of responsiveness and qualification requirements of the bidder.

2. As per the evaluation report the bid has been found to be responsive in terms of clause 3.1.6 of RFP.

2.1 ETEC further noted that the bidder meets the required qualification criteria as per RFP as under:

A.) Threshold Technical Capacity in terms of clause 2.2.2.2 (i):

The Evaluation Committee that the bidder has submitted the required certificate regarding construction work from the Chartered Accountants, Ashwani & Associates certifying the receipts and the shares of the bidder in respect of each project.

2.2 **Bid Capacity:** ETEC noted that the bidder has submitted the details of work executed during the last 5 years duly certified by the client of the respective projects. It was noted that the financial consultant has assessed the Bid Capacity of the responsive bidder i.e. S.P. Singla Construction Pvt. Ltd. as under in terms of clause 2.2.2.1 of RFP:

3. The Committee was informed that the Bank Guarantee submitted towards Bid Security has been transmitted through the SFMS Gateway and Syndicate Bank Transport Bhawan Branch has since vide its letter no 9062/NHIDCL/BG/2018 dated 27.06.2018 has confirmed the same.

4. Based on the evaluation of the documents, ETEC observed that the technical bid of M/s. S.P. Singla Construction Pvt. Ltd. is responsive and technically eligible as per the provisions of RFP. The Committee further recommended that

(i) The bid of M/s. S.P. Singla Construction Pvt. Ltd. may be declared as qualified for opening of the financial bid with the approval of the Competent Authority.

(ii) The financial bid of M/s. S.P. Singla Construction Pvt. Ltd. may be opened online subsequent to the bidder informing the Authority through email in the prescribed format as per Annexure VI A of Appendix-I for any change in their Bid Capacity, due to award/declared to be the lowest bidder in any other project between the period of bid submission and unto two days (48 hrs) prior to the date of opening of the financial bid in terms of clause 3.2 of RFP.
