In case, any document furnished by him/her is found to be false at any stage, it would be deemed to be breach of terms of Contract making him/her liable for legal action besides termination of contract.
- 5. The National Highway and Infrastructure Development Corporation Limited, Roing Branch reserves right to terminate the contract during initial period also after giving three days' notice to the contracting agency in case of breach of terms of contract.
- 6. Duly authorized representative of Bidders will be allowed to participate in the bidding process on production of authorization letter.
- 7. National Highway and Infrastructure Development Corporation Limited, Branch may ask for documentary evidence in respect of payment of statutory liabilities as and when required.
- 8. The successful agency will have to furnish an Affidavit that it is complying with all statutory liabilities relating to taxes, payment of minimum wages and other statutory liabilities before issue of work order.
- 9. The bidder shall furnish, in the format enclosed at Annexure- II, rate per person/per month for PA/Steno, Accountant, Office Assistant, Data Entry Operators, Multi-Tasking Staff (MTS), Chowkidar (Full time) & Safaiwala (part time) etc. (un-skilled, semi- skilled and skilled) (8 hours excluding ½ hour lunch) as applicable for state of Arunachal Pradesh/Central Government Minimum Wages rates (inclusive of minimum wages, plus all statutory payments such as EPC, Goods & Service tax showing the individual components). Separate table may be prepared as per minimum wage rate for State of Arunachal Pradesh and that for Central Government.
- 10. Service provider will pay the wages to the persons deployed through individual bank account opened at **bank of India**.

- 11. The administrative/Service Charge/Any other liability/charges (mentioned in para-5 (v) of page (11) to be charged by the service provider to be quoted separately which will be the indicator of selection of L-1 bidder. The amount so quoted should include liabilities viz. Office uniforms (2 sets for each, Multi-Tasking Staff, Chowkidar & Safaiwala etc. (unskilled, semi-skilled and skilled), bonus (if any), of contractor towards deputed PA/Steno, Accountant, Office Assistant, Data Entry Operators, Multi-Tasking Staff, Chowkidar & Safaiwala Staff etc. (unskilled, semiskilled and skilled) and also include expenses towards their day to day stationery/administrative work/duties.
- 12. Whenever minimum wage is revised by the Government of Arunachal Pradesh/Central Government, the rate in the Contract and the consequential statutory payments shall automatically get revised keeping the Contractors Adm. /Contractor Service Charge/Contractor any other liability charges unchanged.
- 13. National Highway and Infrastructure Development Corporation Limited, Branch shall verify the actual payment of statutory payments periodically, and if not satisfied, shall withhold the payments due to the service provider in addition to other legal action.
- 14. The contracting Company/Firm/Agency shall furnish and undertaking that it has not been debarred/blacklisted/ censored for violating statutory norms and /or deficiency in providing service. This undertaking in addition to the declaration indicated in page no.10.
- 15. All the documents shall be arranged in the order, indicated on page no.19 of this RFP, indexed, page numbered and shall be submitted in hard bound cover.
- 16. After issue of letter of acceptance to the successful bidder, the Steno/PA, Accountant/ Data Entry Operator shall be interviewed by the authority to judge their suitability for the post. The successful bidder has to send the candidates, as mentioned in Annexure I, for the interview at their own cost. The authority reserves the right to accept or reject the candidature on the basis of interview.

LIABILITIES, CONTROL ETC. OF THE PERSONS DEPLOYED

- 1. The contracting agency shall ensure that the individual manpower deployed in the National Highway and Infrastructure Development Corporation Limited, Branch is physically fit to discharge duties of PA/Steno, Accountant, Office Assistant, Data Entry Operators, Multi-Tasking Staff, Chowkidar & Safaiwala Staff etc, (Unskilled, semi-skilled and skilled.)
- 2. "The National Highway and Infrastructure Development Corporation Limited, Branch is under the Union Ministry of Road Transport & Highways and follows the rules fixed by central Govt. The company also observes the Gazetted holidays notified by the Government of India from time to time The PA/Steno, Accountant, Office Assistant, Data Entry Operators, Multitasking staff, Chowkidar (Full time) & Safaiwal (Part time) staff etc. (Unskilled, semi –skilled & skilled), however, may be required to attend the office on Sunday/Gazetted holidays or attend office before/after officer working hours also in the exigencies of work for which the National Highway and Infrastructure Development Corporation Limited, Roing Branch will make payment on pro rata basis.
- 3. The Contracting Company/Firm/Agency shall furnish the following documents in respect of the individual PA/Steno, Accountant, Office Assistant, Data Entry Operators, Multi- Tasking Staff, Chowkidar & Safaiwala Staff etc. (unskilled, semi-skilled and skilled) who will be deployed by it in the National Highway and Infrastructure Development Corporation Limited, Roing Branch before the commencement of work.
 - a) List of persons deployed;
 - b) Bio-data of the person;
 - c) Attested copy of matriculation certificate containing date of birth;
 - d) Character certificate from two Group "A" /Class-I officers of the Central /State Government;
 - e) Certificate of verification of antecedents of persons by local police authority;
 - f) Identity Cards bearing photograph.
- 4. In case the persons employed by the successful Company/Firm/Agency commits any act omission/Commission which amounts to misconduct /indiscipline/incompetence, the successful Company/Firm/Agency will be liable to take appropriate disciplinary /legal action against such persons, including their removal from site of work, if required by the Company.
- 5. The tendering Company/Firm/Agency shall replace immediately any of its personnel who are found unacceptable to the National Highway and Infrastructure Development Corporation Limited, Branch because of security risks, incompetence, conflict of interest, improper conduct etc. on instructions of the National Highway and Infrastructure Development Corporation Limited, Branch.

- 6. The persons deployed shall be required to report for work at 9:30 AM to the General Manager (Project), NHIDCL, Roing Office daily and would not leave before 6:00 PM. In case, person deployed in absent on a particular day or comes late/leaves early on three occasions, one-day wages shall be deducted or any other action as deemed fit may be taken.
- 7. The agency shall depute a coordinator who would be responsible for immediate interaction with the National Highway and Infrastructure Development Corporation Limited, Roing Branch Office so that optimal services of the persons deployed by the agency could be availed without any disruption.
- 8. The selected agency shall immediately provide a substitute in the event of any person absenting for duty on any day, leaving the job or is removed. The delay by the agency in providing a substitution beyond three working days shall attract pre-estimated agreed liquidity damage @ Rs. 200/- per day per person on the service-providing agency.
- 9. It will be the responsibility of the service providing agency to meet transportation, food, medical and any other requirements in respect of the persons deployed by it (Agency) in the National Highway and Infrastructure Development Corporation Limited, will have no liability in this regard.
- 10. For all intents and purposes the service providing agency shall be the "Employer" within the meaning of different Labour Legislations in respect of personnel so deployed in the National Highway and Infrastructure Development Corporation Limited, Roing Branch. The persons deployed by the agency in the National Highway and Infrastructure Development Corporation Limited, Roing Branch shall not have any claims of Master and Servant relationship nor have any principal and agent relationship with or against the National Highway and Infrastructure Development Corporation Limited, Roing Branch. They shall in no case be entitle for claiming regularization/employment in the National Highway and Infrastructure Development Corporation Limited, Branch, on the basis of having rendered services through the Contractor
- 11. The Service providing Agency shall be solely responsible for the redressal of grievances/resolution of disputes relating to person deployed. The National Highway and Infrastructure Development Corporation Limited, Roing Branch shall, in no way be responsible for settlement of such issues whatsoever.
- 12. The National Highway and Infrastructure Development Corporation Limited, Roing Branch shall not be responsible for any damages, losses, claims, financial or injury to any other person deployed by service providing agency in the course of their performing the functions/duties, or for payment towards any compensation.
- 13. The persons deployed by the service providing agency shall not claims nor shall be entitled to pay, perks and other facilities admissible to casual, ad-hoc, temporary regular/confirmed employees of the National Highway and Infrastructure Development Corporation Limited, Branch during the currency or after expiry of the Contract.
- 14. In case of termination of this contract on its expiry or otherwise, the persons deployed by the service providing agency shall not be entitled to and will have no claim or any absorption nor any relaxation for absorption in the regular/otherwise capacity in the National Highway and Infrastructure Development Corporation Limited, Branch.

LEGAL

- 15. The tendering agency will be responsible for compliance of all statutory provisions relating to minimum wages, GST, Provident Fund and Employees State Insurance etc., if applicable in respect of the persons deployed by it in the National Highway and Infrastructure Development Corporation Limited, Roing Branch.
- 16. The tendering agency shall also be liable for depositing any taxes, levies, Cess etc. on account of service rendered by it to the National Highway and Infrastructure Development Corporation Limited, Roing Branch to the concerned tax collection authorities from time to time as per extant rules and regulations on the matter.
- 17. The tendering agency shall maintain all statutory registers under the applicable law. The agency shall produce the same, on demand, to the concerned authority of the National Highway and Infrastructure Development Corporation Limited, Roing Branch or any other authority under law. A compliance certificate in this regard will be submitted along with the bills every month.
- 18. The Tax Deducted at Source (TDS) shall be deducted as per the provisions of the Income Tax Department, as amended from time to time and a certificate to this effect shall be provide to the agency by the National Highway and Infrastructure Development Corporation Limited, Roing branch.
- 19. In case, the tendering agency fails to comply with any statutory /taxation liability under appropriate law, and as a result thereof the National Highway and Infrastructure Development Corporation Limited, Roing Branch is put to any loss/obligation, monetary or otherwise, the National Highway and Infrastructure Development Corporation Limited, Roing Branch will be entitled to get itself reimbursed out of the outstanding bills or the Performance Security Deposit of the agency, to the extent of the loss or obligation in monetary.

FINANCIAL

- 20. The Technical bid should be accompanied with Earnest Money Deposit (EMD), refundable, or Rs.10,000/- (Rupees ten thousand Only), in the form of Demand Draft/Pay Order drawn "in favour of the General Manager (Project), National Highway and Infrastructure Development Corporation Limited, Roing Branch" failing which the tender shall be rejected out rightly. The Annual Turn Over of the Company should not less than Rs.10 lakhs.
- 21. The EMD in respect of the agencies which do not qualify the Technical Bid (First Stage)/Financial Bid (Second Stage) shall be returned to them without any interest. However, the EMD in respect of the successful bidder shall be adjusted towards the Performance Security Deposit. Further, if agency fails to deploy required number of manpower against the initial requirement within 5 days from the date of placing the order the EMD shall stand forfeited without giving any further notice.
- 22. After issue of letter of acceptance, the successful bidder has to submit performance security, amounting to Rs 20000.00(Rs. Twenty Thousand) in the form of Demand Draft/Pay Order drawn "in favour of the General Manager (Project), National Highway and Infrastructure Development Corporation Limited, Roing, within three days.

- 23. In case of breach of any terms and conditions attached to this contract, the Performance Security Deposit of the agency will be liable to be forfeited by the National Highway and Infrastructure Development Corporation Limited, Roing Branch besides annulment of the contract.
- 24. The agency shall raise the bill, in triplicate, along with attendance sheet duly verified by the General Manager (Project) NHIDCL Roing Branch in respect of the persons deployed and submit the same to the General Manager (Project) NHIDCL Roing Branch in the first week of the succeeding month. As far as possible the payment will be released by the second week of the succeeding month. The payment to the manpower should be made by the agency through their individual bank accounts opened at Bank of India, Roing, and the photocopies of disbursed Cheque/documents, along with proof of receipt thereof by the workers will be submitted to the National Highway and Infrastructure Development Corporation Limited, Roing Branch office before the end of each month. National Highway and Infrastructure Development Corporation Limited, Roing branch shall verify the actual payment of statutory payments periodically, and if not satisfied, shall withhold the payments due to the service provider in addition to other legal action.
- 24. The amount of pre-estimated agreed liquidated damages calculated @Rs.200/- per day per person on account of delay, if any, in providing a suitable substitute for the period beyond three working days by the agency shall be deducted from the monthly bills of the service providing Company/Firm/Agency in the following month.
- 25. In case of revision of rates prescribed by the appropriate authority as minimum wage, revision of rates to the extent of increase/decrease in the minimum wage may be allowed by the National Highway and Infrastructure Development Corporation Limited, Roing Branch.
- 26. The National Highway and Infrastructure Development Corporation Limited, Roing Branch reserves the right to withdraw/relax any of the terms and conditions mentioned above so as to overcome the problem encountered by the contracting parties.
