- 3. **International Competitive bidding** will be conducted in accordance with ADB's <u>Single- Stage: Two-Envelope</u> bidding procedure and is open to all bidders from eligible source countries as described in the Bidding Document.

However, Bid Security, document fee, Power of Attorney and joint bidding agreement shall be submitted physically by the Bidder on or before the date of Financial Opening (which shall be intimated later). Bids received shall be opened on 11.08.2020 at 1500 hours IST.

To participate in the e-tendering process, a Bidder should be in possession of Class III Digital Signature Certificate (DSC) in the name of the person duly authorized to sign on behalf of the Bidder from any of the licensed Certifying Agency (CA) (The shortlisted bidders can see the list of licensed CA"s from the link <a href="https://www.cca.gov.in">https://www.cca.gov.in</a>).
