TERMS OF REFERENCE (TOR) OF TECHNICAL BID

Terms and Conditions:

- 1. The vehicles should be registered after 01 JAN 2020 and should not have run more than 30,000 Km at the time of providing the vehicle. The vehicles should be in good running condition during the contract in case the bidder proposed to provide new vehicle, the relevant documents shall be submitted before execution of agreement. Agency shall have to change the vehicle after its run crosses 75000 km mark.
- 2. The Tender shall be submitted in a master envelope containing following:
 - (i) Envelope One containing Technical Bid and Terms of Reference (TOR) of Technical Bid in properly sealed cover & hard bound and super scribed as "Technical bid for Tender of vehicle for RO Srinagar".
 - (ii) Envelope two containing Financial Bid only.
 - The bidder shall submit information as given in Technical Bid Annexure-I along with self-attested copies of documents supporting the information. In case the vehicle is not owned by bidder, a notarized contract agreement may be attached between the vehicle owner & bidder. If the bidder fails to provide vehicles as per annexure I & II, his bid shall be liable for rejection.
- 3. The vehicle provided should either be owned in the name of the applicant or may be hired from other sources. However, in case of hiring of vehicle from other sources, necessary documents need to be submitted. Once the bid is accepted, the service provider shall produce all original documents related to ownership/hiring of the vehicle from other sources for verification. An agreement/ contract will be signed with the successful bidder within 05 (Five) days of issue of award letter.
- 4. The vehicle should be in good running condition and well maintained preferably with top safety features like Anti-Lock Braking System, fog lamps, parking lights, air bags for front seats, indicators, horn etc. suited for extensive running on high traffic density highways and Kaccha roads. The vehicle shall comply BS-VI emission norms. The successful bidder shall bear full responsibility for the safety of vehicle, its occupants and any third party and NHIDCL officials / representatives will be indemnified by the successful bidder on this account. Vehicle should be preferably of top variant of its class / category.
- 5. All necessary taxes for operating the vehicle should be fully paid and all necessary papers shall be provided in the vehicle as required by prevailing Motor Vehicles Act with comprehensive insurance cover for the vehicle, its occupants and any other 3rd party. Cost of insurance will be fully borne by Successful bidder and the rate quoted shall be inclusive of this.

- 6. NHIDCL reserves the right to use the vehicle at Sl. No. 3 in Table at Annexure-II round the clock without paying anything extra. The vehicles at Sl. No. 1 and 2 in Table at Annexure-II will be used from 9.00 AM to 7.00 PM daily. NHIDCL will not be responsible for parking, accommodation and facility of meals for the driver and hence agency should make above arrangements on their own.
- 7. Agency shall make available driver with adequate salary & DA (for outstation travel) having valid driving license with experience of running on Highways. The driver shall be well trained, physically & medically fit, well behaved and suitably dressed.
- 8. The vehicle and driver provided with a vehicle shall not be changed or altered for entire agreement period unless approved/accepted by NHIDCL in writing.
- 9. The successful bidder shall bear all expenses required for keeping the vehicles in smooth running condition such as fuel, lubrication oil & other consumables, necessary periodic service, repair & maintenance, driver & replacements etc. The rates quoted shall be inclusive of all these provisions and nothing extra will be paid on any account.

10. <u>Penalties:</u>

- (A) In the event of any vehicle being rendered unfit for plying / service on account of maintenance, break down or for any other reason, the successful bidder shall provide a substitute vehicle immediately. If the substitute vehicle is not provided, a penalty of Rs. 2500/- per day shall be affected from the bills of agency.
- (B) The vehicle provided by successful bidder shall be kept clean externally and internally and in top working condition at all times failing which a penalty of Rs. 500/- per day shall be affected from the bill of agency. The vehicle shall be provided with name plate of NHIDCL, if required, as approved by NHIDCL, on front and rear side of the vehicle. Vehicle shall be exclusively in the custody of NHIDCL for all the time & for all purposes.
- 11. Agency shall quote their rates on monthly basis i.e., per vehicle per month subject. In case of excess km run by the vehicle, the payment of extra kms will be made after adjusting the extra kms against the shortfalls in every three months. The amount quoted for 3000 kms/2500kms/2000 kms for the vehicle shall only be considered for evaluation of the financial bid. Rate of Extra Km and Rate of overtime hours shall be quoted by every bidder and the successful bidder shall have to keep the rate of extra km as per the lowest bid against the said item.
- 12. The vehicle provided should have permit to travel in All India.
- 13. The agency should ensure that sufficient fuel is always available for travel minimum up to 300 km all times.
- 14. The agency shall ensure that the odometer of the vehicle supplied, is properly sealed so that no tempering is done to inflate kilometre distance travel.
- 15. No advance payment shall be made under any circumstances.
- 16. The quoted rates for hire charges per month include salary & other charges of driver, cost of all lubricants, maintenance, repair including cost of spares etc & any other incidentals as may be required. The quoted rates shall be inclusive of all taxes & other charges applicable in the UT of Jammu and Kashmir including entry tax. For running of vehicle in other states the applicable taxes of such states shall be paid by the firm and such amount

shall be reimbursed to him on production of such vouchers during the payment of monthly bill. Toll charges as per actual shall be claimed at the time of monthly payment with receipts verified by the user.

- 17. No payment in addition to the quoted rates on any account whatsoever will be made / reimbursed unless it is specifically mentioned under these terms and conditions.
- 18. The GST will be reimbursed on submission of proof of payment only with necessary certification from CA Firm as required by the NHIDCL RO-Srinagar as per NHIDCL policy.
- 19. In case of breach of terms & conditions performance by agency and in case of rash/inappropriate driving, NHIDCL may terminate the agreement immediately without assigning reasons. Decision of NHIDCL is final and binding.
- 20. The Kilo meter counting of the vehicle shall start from the designated office and shall end at the designated office. Odometer must be correctly calibrated at all times.
- 21. The successful bidder has to provide the vehicles as per requirements of the NHIDCL. The number of vehicles may increase or decrease during the period of validity of the tender. Payment will be made on the basis of actual number of vehicles hired and operated during the relevant month/period.
- 22. The vehicles will be operated in AC mode.
- 23. The service provider/driver should have a mobile telephone for contact round the clock. Cost & Bills will be borne by the service provider. No accommodation is provided to Driver by the NHIDCL.
- 24. Once hired, the vehicle will not be put to use for other purposes, and the vehicles and drivers will work under the overall supervision of the NHIDCL for which they will do all as is necessary.
- 25. In order to ensure day to day functionality of NHIDCL, once hired, service provider shall not keep changing or rotating vehicles and drivers, except if the NHIDCL so indicates in the case of eventuality or unsuitability and vehicle could be used without any driver for other purposes if need arises.
- 26. It is clarified that the engagement of service provider for providing vehicle on contract basis does not in any manner confer any right on the service provider or any other person/driver may be deployed by her/him in NHIDCL to claim any regular employment in NHIDCL or any government office. The owner/service provider will be solely responsible for all wages/dues to the driver and to follow all the rules/provisions as per the Motor Vehicle Act & its amendments. NHIDCL shall not be responsible for any dispute/liability whatsoever in this regard.
- 27. Additional accessories for the vehicles for running in snow bound region, if required, will be provided by the service provider at his own cost and no extra payment will be made in this regard.
- 28. Either party may terminate the contract without showing any cause with 15 days prior notice. No claim of firm/ party shall be entertained in such event even if the service provider has taken loan to purchase the vehicle.
- 29. The agency should submit their bills in duplicate along with logbook within 1st week of every month for payment. It is the responsibility of bidder to maintain the logbook for

vehicle and get it certified from the concerned official using the vehicle on regular basis, failing which, payment shall not be made.

- 30. No variation/revision in quoted rates for any reason will be entertained during the contract period.
- 31. The successful bidder should be able to supply the required vehicles within 5 days or as directed by NHIDCL from the date of issue of 'Letter of Acceptance' by NHIDCL.
- 32. The supply of vehicles is initially for duration of two years only from the date of issue of Letter of Acceptance. The agreement will be made with the lowest bidder for a period of Two years as per terms & conditions mentioned in the bid document and rates accepted by NHIDCL. The agreement may be extended beyond two years on mutual consent of both parties depending upon performance of travel agency and on recommendation of the concerned official for one more year.
- 33. The successful bidder shall submit all required documents of vehicle, driver, insurance, Road Tax, GST etc, to execute the agreement within 5 days of issue of 'Letter of Acceptance' on a Rs. 100/- non judicial stamp paper, failing which 2nd lowest bidder may be considered for award of Tender at the lowest rate quoted in the bidding.
- 34. During the tendering process, NHIDCL reserves full rights to curtail, modify, halt / cancel, reject any or all offer/s, at any stage without assigning any reasons and no claims of whatsoever nature will be entertained on this account.

37. <u>Performance Security</u>: -

- (b) The Performance Security will be refunded / released to the agency / service provide-within 30 days after successful completion of the Contract Period (including any extensions thereof) and compliance of all conditions of the Agreement.
- 38. The Bid Security/Earnest Money will be forfeited
 - A. Any Tender without Earnest Money/ Bid security shall be considered non-responsive.
 - B. If the Bidder withdraws the Bid after its submission.
