Minutes of the Meeting of the Technical Evaluation Committee constituted for selection of Agency for entering into Annual Rate Contract for providing services of Designing, Printing of documents such as books/Annual Reports etc. in NHIDCL, Head Quarter, New Delhi held on 21.10.2016, 25.10.2016 & 26.10.2016.

The committee constituted vide NHIDCL office order no. NHIDCL/HR Office Orders/2016-17/84 dated 06.05.2016 was informed on 15.10.2016 that NHIDCL has invited offers from various firms for selection of Agency for entering into Annual Rate Contract for providing services of Designing, Printing of documents such as books/Annual Reports etc. in NHIDCL, Head Quarter, New Delhi and that the last date of receipt of bids was 14.10.2016 till 3:00 PM. The date and time of opening of technical bids was 4:00 PM on the same day.

The committee consisting of GM (HR), DGM (HR), DGM (Fin.) Sh. K.C. Bhatt DGM (Tech.) met at 1600 hours on 21.10.2016 and was informed that as on the last date & time of submitting bids only seven bids from the following firms are received.

The committee was further informed that as per the evaluation criteria a minimum of 70 marks out of 100 marks is required for qualifying in Technical Bid Evaluation based on the criteria in the tender document. The financial bids of the bidders who qualify in the technical evaluation shall be opened and the evaluation shall include all cost and all taxes and duties applicable to the bidder as per the law of the Central/State Government/Local Authority.

The documents received from six bidders in response to our e-mail dated 25.10.2016 and all the seven technical bids were placed before the committee. The technical committee evaluated the bids received from the 7 bidders along with the additional documents received. A comparative statement as per the details contained in the statement placed at Annexure-I.
