2. Having opened the Technical bids on 17.10.2018, the Committee (ETEC) met on 13.12.2018 to undertake the 1<sup>st</sup> Stage Evaluation in accordance with the provisions of RFP.

#### 3. First Stage Evaluation:

3.1 The Committee noted in the first instance that as per the evaluation done on the INFRACON Portal Four bidders qualify out of Six bidders as per **Appendix-I**. The ETEC undertook the further verification of the INFRACON results and observed the following in respect of each proposal:

#### 3.1.1 L&T Infrastructure Engineering Limited

The proposal was examined vis-à-vis the INFRACON Portal results and firm has passed the proof of eligibility and is therefore eligible for the second stage evaluation. The details are placed at **Annexure-I** of **Appendix-II** respectively.

3.1.2 Voyants Solutions Private Limited in JV with Aushta Consulting Engineers (India) Pvt. Ltd.

The proposal was examined vis-à-vis the INFRACON Portal results and firm has passed the proof of eligibility and therefore eligible for the second stage evaluation. The details are placed at **Annexure-II** of **Appendix-II** respectively.

# 3.1.3 C M Engineering & Solution in Association with Construct-M Project Management Consultancy

The proposal was examined vis-à-vis the INFRACON Portal results and committee noted that firm has not uploaded the financial turnover for the year 2017-18 and failed to qualify in terms of the annual average turnover of last 3 years as per the RFP, the average annual turnover of the firm should be equal to or more than Rs. 5 Crore i.e. from 2015-16 to 2017-18. The details are placed at **Annexure-III** of **Appendix-II** respectively

# 3.1.4 Rodic Consultants Pvt. Ltd. In JV with Monarch Surveyors and Engineering Consultants Pvt. Ltd

The proposal was examined vis-à-vis the INFRACON Portal results and firm has passed the proof of eligibility and eligible for the second stage evaluation. The details are placed at **Annexure-IV** of **Appendix-II** respectively.

### 3.1.5 Almondz Global Infra-Consultant Limited in JV with Manglam Associates

The proposal was examined vis-à-vis the INFRACON Portal results and committee noted that as per manual evaluation firm failed to qualify in the eligibility requirement i.e. Firm applying for a package as Joint venture the lead partner should have experience of preparation of Detailed Project Report of two/four/six lane/Feasibility of Two/ four/ six lane projects of aggregate length equal to 75% of the indicative length of the package (i.e. 98.625km indicative length of the package is 131.5km). Firm has only 86.33 Km of aggregate length and the firm has no single project of 2/4/6 laning of minimum 40% of the 75% of indicative length of the i.e. **39.45** Km Or Feasibility Study for 2/4/6 minimum 60% of 75% of the indicative length of the package i.e. 59.175 Km. As per the INFRACON evaluation firm has not uploaded the financial turnover of last three i.e. from 2015-16 to 2017-18. Further, committee noted that firm failed to meet the annual average turnover criteria of last 3 year which should be equal to or more than Rs. 5 Crore. The details are placed at Annexure-V of Appendix-II respectively.

## 3.1.6 Jindals Consortium in Association with Advent Consulting Engineers

The proposal was examined vis-à-vis the INFRACON Portal results and firm has passed the proof of eligibility and eligible for the second stage evaluation. The details are placed at **Annexure-VI** of **Appendix-II** respectively.

4. The Committee after due deliberation recommended that the following firms are eligible for the second stage of bid evaluation:
