Subject-Minutes of Meeting of Empowered Technical Evaluation Committee(ETEC) for evaluating Technical Bids for " Consultancy Services for Feasibility Study, Preparation of Detailed Project Report and providing pre-construction services for up gradation of selected road stretch/corridor to Two lane with paved shoulders NH configuration under BHARATMALA Project and National Highways connectivity to Backward areas/Religious/Tourist places of the country in the state of Arunachal Pradesh" held at NHIDCL on 06.01.2017.

1. The REP for the above subject work was invited with bid due date being **26.12.2016** upto **1700 hrs.** The following bidders had participated and submitted their bids.

2. ETBC vide minutes of meeting dated 26.12.2016 has opened the Technical bids and found them responsive hence recommended that the bids of all the bidders to be technically evaluated.

3. The Technical Evaluation has been carried out through INFRACON and the scores evaluated are as below.

4. Two key personnel of M/s C. E. Testing Company Pvt. Ltd one from Central Team i.e. **Revenue/Survey Expert** and Second from Sub Team i.e. **Highway Engineer** could not score the minimum qualifying marks of 75%. Committee noted that M/s C.E. Testing Company Pvt. Ltd may be asked to give replacement for the key professional who has scored less than 75% marks, if they become the preferred bidder at the time of negotiation as per Clause 6.6 of RFP.

5. One Sub-Team key personnel of M/s EPTISA SERVICIOS DE INGENIERIA, S.L. i.e. **Highway Engineer** could not score the minimum qualifying marks of 75%. Committee noted that M/s EPTISA SERVICIOS DE INGENIERIA, S.L. may be asked to give replacement for the key Personnel who has scored less than 75% marks.

6. Three key personnel of M/s S.M. Consultants one from Central Team i.e. **Revenue/Survey Expert** and two from Sub Team i.e. **Quantity Surveyor cum Documentation Expert** and **Highway Engineer** could not score the minimum qualifying marks of 75%. Committee noted that M/s S.M. Consultants may be asked to give replacement for the key professional who has scored less than 75% marks, if they become the preferred bidder at the time of negotiation as per Clause 6.6 of RFP.

7. Three key personnel of M/s Choice Consultancy Services Private Limited two from Central Team i.e. **Revenue/Survey Expert**, **Hill Road/Tunnel Expert** and one from Sub Team i.e. **Highway Engineer** could not score the minimum qualifying marks of 75%. Committee noted that M/s Choice Consultancy Services Private Limited may be asked to give replacement for the key professional who has scored less than 75% marks, if they become the preferred bidder at the time of negotiation as per Clause 6.6 of RFP.

8. M/s Aqua Pumps Infra Ventures Limited has failed to score the minimum qualifying marks i.e. 75% marks. Therefore, M/s Aqua Pumps Infra Ventures Limited is **Technically disqualified**.

9. The Team Leader of M/s Chaitanya Projects Consultancy Pvt. Ltd. in association with M/s Agnitio Infrastructure Projects Pvt. Ltd. fails to score the minimum qualifying marks i.e. 75% marks. The Team Leader could only score 59.5 marks. As per clause 3.2.4 of RFP "The CV of the proposed Team Leader should score at least 75 % marks otherwise the entire proposal shall be considered to have failed in the evaluation of Technical Proposals and shall not be considered for opening of Financial Proposals". Therefore,
