- (iii) 2 Laning of Existing Hunli- Anini Road on EPC basis from design km. 53.300. To Km. 92.500. (Existing Km 56.320 to Km 97.670) Package-11 in the state of Arunachal Pradesh under SARDP NE. (Total Length: 32.00Km)
- (iv) 2 Laning of Existing Hunli- Anini Road on EPC basis from design km. 92.500. To Km. 131.920. (Existing Km 97.670 to Km 138.384) Package-III in the state of Arunachal Pradesh under SARDP NE. (Total Length: 39.420Km).

1	To calculate value of 'A' i.e. to evaluate the Bid Capacity in ANNEX-VI of Appendix —IA it has been mentioned in the RFP to provide the Value of Civil Engineering works for the last 5 FY i.e. from 2009-10 to 2013-14. However the last five years as of now preceding the bid submission date is from 2010-11 to 2014-15. So our question is whether we have to use the value of civil engineering works from 2009-10 to 2013-14 or from 2010-11 to 2014-15?	Replies to S.No 1 to 4 are as follows: Please refer to clause 2.1.17 and clause 2.2.2.8 (ii) of RFP in this regard which clarifies that financial year from 2009-10 to 2013-15 are to be considered for the said purpose.
2	To calculate value of 'B' i.e. to evaluate the value of existing commitments & ongoing works in ANNEX-VI of Appendix —IA it has	

	been mentioned in the RFP that the up dation factor for the last 5 FY i.e. from 2009-10 to 2013-14 is to be considered. However the last five years as of now preceding the bid submission date is from 2010-11 to 2014-15. So our question is whether we have to use the up dation factor for ongoing commitments from 2009-10 to 2013-14 or from 2010-11 to 2014-15?	
3	In ANNEX-III of Appendix IA of the RFP it has been mentioned that the Bidder will have to attach copies of balance sheets, financial statements and annual reports for 5 years preceding the bid due date. In this case we would like to know whether we will have to attach copies of balance sheets, financial statements and annual reports for the last 5 years i.e. from 2010-11 to 2014-15 or from 2009-10 to 2013-14?	
4	Overall we would like to know which set of 5 nos. of Financial Years i.e. from 2009-10 to 2013-14 or from 2010-11 to 2014-15 we will have to follow for every aspect of Bid submission in both Technical and Financial Part ?
