6. The site for the work is available for Repair & Maintenance and other requisite works as and when required as per work order.
7. Bidder shall submit the following documents in physical form in original and in scanned copy to be uploaded.
 - i. Copy of PAN Card.
 - ii. Demand Draft for cost of documents.
 - iii. Demand Draft/Bank Guarantee for Bid Security (Bid Security Declaration should be submitted).
8. The interested bidder can download the NIT/ bidding document from the website <https://eprocure.gov.in/eprocure/app> & www.nhidcl.com.
9. To participate in bidding process, bidder has to get (DSC) "Digital Signature Certificate" as per Information Technology Act-2000, to participate in online bidding. This certificate will be required for digitally signing the bid. Bidder can get above mentioned digital certificate from any approved vendors. The Bidder, who already posses valid (DSC)"Digital Signature Certificate" need not to procure new Digital Signature Certificate.
10. The bidders have to submit their bids online in electronic format with Digital Signature. The bid cannot be uploaded without Digital Signature. No proposal (Except the documents as mentioned in point 7 above) will be accepted in physical form.
11. Bids will be opened online as per time schedule mentioned at **Sr. No.19**.
12. Before submission of online bids, bidder must ensure that scanned copy of all the necessary documents have been attached with bid.
13. The department will not be responsible for delay in online submission of bids whatsoever reasons maybe.
14. All the required information for bid must be filled and submitted online.
15. Bidders should get ready with the scanned copies of cost of documents & Bid Security (**declaration**) as specified in the tender documents. The original instruments in respect of cost of documents, Bid Security and relevant documents will be submitted to the Tenders Inviting Authority by Registered post/courier/by hand as per time schedule specified or at the time of signing of the Contract Agreement. However, the Document Fee should be submitted online through RTGS/NEFT and a receipt should be uploaded online on account of proof and record purpose.
16. The details of cost of documents, specified in the tender documents should be the same, as submitted online (Scanned copies) otherwise bid will not be accepted.
