



Minutes of Meeting of Empowered Technical Bid Evaluation Committee (ETEC) to evaluate technical bid for “**Consultancy services for Authority’s Engineer for Supervision of Four Laning of Imphal - Moreh Section of NH 39 from Km 330.000 to Km 350.000 (Contract Package I) and Two Laning of Imphal - Moreh Section of NH 39 from Km 350.000 to Km 395.680 in the State of Manipur (Contract Package II) under Engineering Procurement and Construction (EPC) Mode ”** at NHIDCL on 01.01.2018, New Delhi-**Technical Bid Evaluation-** reg.

- 1) The RFPs for the subject work were invited on 27.10.2017 with bid due date as **18.12.2017** till 1500 hrs.
- 2) In all 05 proposals (based on data uploaded on Infracon portal) were received physically from the consulting firms viz. **M/s Voyants Solutions Private Limited., M/s Feedback Infra Private Limited , M/s Rodic Consultants Pvt. Ltd.-Tpf Getinsa Euroestudios S.L. (JV), M/s SMEC International Pty. Ltd. - SMEC (India) Pvt. Ltd. (JV) and M/s Technocrats Advisory Services Private Limited in association with Agnitio Infrastructure Projects Pvt. Ltd.** However, only 4 (four) out of 5 (five) proposals were found on e-portal. The bid of **M/s Rodic Consultants Pvt. Ltd.-Tpf Getinsa Euroestudios S.L. (JV)** was not submitted online, hence the bid opening committee (ETBC) did not open the technical bid. Other four envelopes containing bid document cost, bid security, Power of Attorney etc were opened immediately thereafter by ETBC in the presence of bidders representative who choose to attend. Further the ETBC decided to evaluate all the 4 (four) Technical Bids through INFRACON.
- 3) The technical proposals of all the four aforesaid bidders were evaluated through Infracon and following results are obtained:
 - a) The evaluation for ascertaining the Proof of Eligibility in accordance to Clause 11 of SECTION 1: INFORMATION TO CONSULTANTS of RFP (**Annexure A**) and the details is as under:

- 6) The committee deliberated the evaluation through INFRACON in detail and observed following:
- It can be seen from Para 3 above, only 3 (Three) out of four bidders are eligible for the next stage. M/s Technocrats Advisory Services Private Limited in association with Agnitio Infrastructure Projects Pvt. Ltd. does not meet the Annual Average Turnover of Rs 17.397 Cr. in accordance with Clause 11 of SECTION 1: INFORMATION TO CONSULTANTS of RFP.
 - The technical scores of proposal of 2 (Two) bidders out of 3 (Three) eligible bidders viz. M/s Feedback Infra Private Limited and M/s SMEC International Pty. Ltd. - SMEC (India) Pvt. Ltd. (JV) are more than 75 marks out of 100 marks as mentioned in Para 5 above. Hence, only 2 (Two) bidders are technically responsive *as per clause 5.3 of Letter of Invitation (LOI) of RFP* for next stage.
 - The score of Team Leader cum senior Highway Engineer of both the aforesaid 2 (Two) eligible bidders is more than 75 marks out of 100 marks.
 - M/s Feedback Infra Private Limited
The technical score of Senior Quantity Surveyor and a Bridge/ Structural Engineer is less than minimum qualifying marks i.e. 75 marks, however we may ask the bidder during negotiation to give a replacement for the key professional who has scored less than 75% marks by a person of at least 75% score *as per para iv (f) of Clause 3.4 of Letter of Invitation (LOI) of RFP*.

e) M/s SMEC International Pty. Ltd. - SMEC (India) Pvt. Ltd. (JV)

The technical score of Senior Quantity Surveyor and a Material Engineer is less than minimum qualifying marks i.e. 75 marks, however we may ask the bidder during negotiation to give a replacement for the key professional who has scored less than 75% marks by a person of at least 75% score as per para iv (f) of Clause 3.4 of Letter of Invitation (LOI) of RFP.

7) Keeping in view Para 6 above, 02 (Two) bidders are found technically qualified and eligible for opening of financial bids. The details of score are as under:
