As recommended in the 1st TEC, list of eligible bidders for financial opening has been published on 08.07.2021 on CPP Portal. Thereafter, two representations from M/s C K Infrastructure Ltd - P. P. Pandey Infrastructure Pvt. Ltd. (JV) and M/s Ganesh Ram Dokania have been received on 09.07.2021. The representations have been examined by the TEC and comments of the TEC are as given follows :-

P. Pandey Infrastructure Pvt. Ltd. is calculated 70.65 by us. Collectively technical score should be 192.62 + 70.65. Consider our bid for financial opening.	<p>Committee has examined the representation and it was found that there was an inadvertent typographical error in the earlier figure which was mentioned as 90.10 instead of 190.10. However, the calculations have now been reviewed and the final figure reads 192.62 instead of 90.10.</p> <p>Regarding the other member's threshold published in the MoM dt. 08.07.2021, same has been found to be in order as per the RFP clause 2.2.2.2 (i) & 2.2.2.6 (ii), so the figure of 42.21 remains unchanged.</p> <p>Accordingly, even after the correction, the bidder is still not eligible for financial opening as the other member does not fulfil the criteria of clause 2.1.11 of RFP. Hence, the final result remains unchanged.</p>

The committee has examined the representation and has found that as per clause 2.1.13, 2.2.2.2 and 2.2.2.6(ii) of RFP, the bidder is not meeting the criteria and hence the result remains unchanged.
