### **SCOPE OF WORK AND GENERAL INSTRUCTIONS**

- 1. The National Highways and Infrastructure Development Corporation Limited, Branch Office Dimapur, requires experienced reputed, well established and financially sound Manpower Companies /Firms/Agencies to provide PA/Steno, Accountant, Office Assistant, Data Entry Operators, Multi-Tasking Staff (MTS), Chowkidar and Safaiwala (Part time) etc. (un-skilled, semi-skilled and skilled) manpower supply & services to this Office.
- 2. The Contract will be for a period of 2 (**Two**) **years** from the date of award of contract. The period of contract may be further extended or curtailed /terminated at any time before expiry of 1(one) year period depending upon requirement of office by giving 2 months prior Notice.
- 3. The office has requirement for services of PA/Steno, Accountant, Office Assistant, Date Entry Operators, Multi-Tasking Staff (MTS), Chowkidar and Safaiwala (Part time) as per the guidelines of NHIDCL. The requirement of the office may increase or decrease during the period of contract.
- 4. - 6. If the space or furnishing information is insufficient, a separate sheet duly signed by the authorized signatory may be attached. No overwriting or cutting is permitted in the Financial Bid Form. In such cases, the bidder shall be summarily rejected. However, corrections if any, in the Technical Bid Application must be signed by the person authorized to sign the tender bids.
- 11.   - b) The Company/Firm/Agency should have at least three years' experience in providing manpower to reputed Private Companies/Public Sector Undertaking/Banks/Government Departments etc. and proof of which should be enclosed with the technical bid.
  - c) The Company/Firm/Agency should be registered under GST.
  - d) The Company/Firm/Agency should be registered with Appropriate Authorities under Employees Provident Fund and Employees State Insurance Act.
  - e) Copy of PAN card and last 03 years IT returns filed.
  - f) Proof of working with Ministries/Government offices/organizations/Reputed Private Companies/Public Sector Companies/Banks and Government Departments etc. for **03** (**three**) **years** and the number of persons deployed by the agency each year in the **last 3 years**.
  - g) Certificate of annual return from CA. The Annual Turn Over of the company should not be less than Rupees 10 lakhs.

### **General Terms and conditions of contract**

- 1. The contract may be extended, on the same terms and conditions or with some addition/deletion/modification, for a further specific period mutually agreed upon by the successful service providing Company/Firm/Agency and National Highways and Infrastructure Development Corporation Limited., Branch office Dimapur, Nagaland.
- 2. The contracting Company/Firm/Agency shall not be allowed to transfer, assign, pledge or sub-contract its rights and liabilities under this contract to any other agency without the prior written consent of this Company.
- 3. The National Highways and Infrastructure Development Corporation Limited, Branch office Dimapur, Nagaland at present, is in requirement of manpower. The requirement of the National Highways and Infrastructure Development Corporation Limited, Branch office Nagaland may increase or decrease during the period of initial contract also and the bidder would have to provide additional manpower, if required on the same terms and conditions.
- 4. The bidder will be bound by the details furnished by him/her to the National Highways and Infrastructure Development Corporation Limited, Branch office Dimapur, Nagaland while submitting the tender or at subsequent stage. In case, any document furnished by him/her is found to be false at any stage, it would be deemed to be breach of terms of Contract making him/her liable for legal action besides termination of contract.
- 5. General Manager (P), Branch Office Dimapur, Nagaland National Highways and Infrastructure Development Corporation Limited, reserves right to terminate the contract at any stage by giving one month notice period by either of the party.
- 6. Duly authorized representative of Bidders will be allowed to participate in the bidding process on production of authorization letter.

The National Highways and Infrastructure Development Corporation Limited, Branch office, Dimapur, Nagaland has 06 days working (i.e. Monday to Friday) in a week from: 09:00 AM to 05:30 PM with a lunch break of ½ hour from 1:00 PM to 1:30 PM or as per office order time to time, as fixed by this office subject to condition that working hours per week shall not exceed 48 hrs. The office will remain closed on every Saturday and Sunday of every month. Besides, the Company also observes the Gazetted holidays notified by the Government of India from time to time. The persons deployed shall be required to report for work at 09.00 A.M to the GM (P), NHIDCL, Branch office, Dimapur, Nagaland daily and would not leave before 05.30 P.M. or as per office order time to time. In case, person deployed is absent on a particular day or comes late/leaves early on three occasions, one-day wage shall be deducted or any other action as deemed fit may be taken.
- 6. The agency shall depute a coordinator who would be responsible for immediate interaction with the National Highways and Infrastructure Development Corporation Limited, Branch office, Dimapur, Nagaland so that optimal services of the persons deployed by the agency could be availed without any disruption.
- 7. The selected agency shall immediately provide a substitute in the event of any person leaving the job or is removed. The delay by the agency in providing a substitution beyond three working days shall attract pre-estimated agreed liquidity damage @ Rs. 500/- per day per person on the service-providing agency.
- 8. It will be the responsibility of the service providing agency to meet transportation, food, medical and any other requirements in respect of the persons deployed by the Agency. - 9. The persons deployed by the agency in the National Highways and Infrastructure Development Corporation Limited, Branch office, Dimapur, Nagaland shall not have any claims of Master and Servant relationship nor have any principal and agent relationship with or against the National Highways and Infrastructure Development Corporation Limited, Branch office, Dimapur, Nagaland. They shall in no case been entitled for claiming regularization/employment in the National Highways and Infrastructure Development Corporation Limited, Branch office, Dimapur, Nagaland, on the basis of having rendered services through the Manpower Agency.
- 10. The Service providing Agency shall be solely responsible for the redress of grievances/resolution of disputes relating to person deployed. The National Highways and Infrastructure Development Corporation Limited, Branch office, Dimapur, Nagaland shall, in no way be responsible for settlement of such issues whatsoever.
- 11. The National Highways and Infrastructure Development Corporation Limited, Branch office, Dimapur, Nagaland shall not be responsible for any damages, losses, claims, financial or injury to any other person deployed by service providing agency in the course of their performing the functions/duties, or for payment towards any compensation.
- 12. The persons deployed by the service providing agency shall not claim nor shall been entitled to pay, perks and other facilities admissible to casual, ad-hoc, temporary regular/confirmed employees of the National Highways and Infrastructure Development Corporation Limited, Branch office, Dimapur, Nagaland during the currency or after expiry of the Contract.
- 13. In case of termination of this contract on its expiry or otherwise, the persons deployed by the service providing agency shall not be entitled to and will have no claim or any absorption nor any relaxation for absorption in the regular/otherwise capacity in the National Highways and Infrastructure Development Corporation Limited, Branch office, Dimapur, Nagaland.

### **LEGAL**

- 1. The tendering agency will be responsible for compliance of all statutory provisions relating to minimum wages, GST, Provident Fund and Employees State Insurance etc., if applicable in respect of the persons deployed by it in the National Highways and Infrastructure Development Corporation Limited, Branch office, Dimapur, Nagaland.
- 2.
