2. The bids are invited under two bid system i.e. Technical Bid and Financial Bid. 15. EVALUATION AND SELECTION

- a. The bids shall be evaluated in two stages i.e. Technical Evaluation and Financial evaluation.
- b. The Financial bids shall be opened of those bidders who will qualify in the technical evaluation.

16. <u>AWARD OF CONTRACT</u>

- b. In case two or more technically qualified firms quote the same lowest price, the firm having the highest Average Annual Turnover during the last three FY i.e. 2016-17, 2017-18 & 2018-19 among the lowest bidders shall be awarded the contract.
- c. The contract shall be for one year from the date of signing of contract.
- d. Any effort by a bidder to influence NHIDCL decision on bid evaluation or placement of work order may result in rejection of the bidders offer.

17. PERFORMANCE SECURITY:

- a. The successful bidder will submit performance security of Rs.25,000/-(Rupees Twenty Five Thousand only) in shape of Account payee Demand Draft/ Pay order from any nationalized/ scheduled bank in favour of NHIDCL, payable at NHIDCL, New Delhi.
- b. The EMD of all the bidders shall be returned immediately after the successful bidder submits the performance security as per the order. If the successful bidder fails to submit the performance security, the

- EMD of that bidder will be forfeited and the bidder shall be debarred from NHIDCL tenders for three years.
- c. The performance security of the successful bidder will be returned to the bidder without interest only after successful completion of the work as per order.
- d. If the successful bidder fails to execute the order, the performance security will be forfeited and action will be taken to blacklist the firm.

SCOPE OF WORK

- 1. Disinfection of NHIDCL premises in PTI building, Sansad Marg, New Delhi of 12364 sqft area and in Jeevan Tara Building at Ashok Road, New Delhi of 1948 sqft area.
- 2. Disinfection of about 15 staff cars, in addition to above area.
- 3. The dis-infection shall be done to ensure that that COVID-19 virus is completely eliminated from the disinfected area/ places/ vehicle.
- 4. Such disinfectants having Broad spectrum microbiocidal shall be used as are non-corrosive and non-staining.
- 5. Chemicals used in the treatment should have efficacy to eliminate bactericidal, fungicidal, viricidal and T.B. Cidal activities and fully effective against Swine Flu, H1N1, Influenza and Corona Virus like 229-E and COVID-19.
- 6. The Disinfection/ Sanitization Spray should cover all the places in office premises like workstations, overhead cupboards, sofas, space under the tables, chairs, almirahs, on and around the pile of files, wooden furniture, false ceiling, staircases, lift body; all toilets drain ducts, washroom area, meeting room, open areas, cafeterias, stores and any hidden space under the furniture, walls/all other surfaces and no space should be left unattended.
- 7. Only FDA approved products shall be used.
- 8. The premises and staff cars shall be sprayed/ fogged daily (05 days a week) till the pandemic of COVID-19 is over or as may be required. The frequency may be increased or decreased at the discretion of NHIDCL.
- 9. NHIDCL shall at random get the sample of the material/ mixtures used for spray/ fogging tested and in case it is found that the material used is either not as per given specification or is substandard, the agency shall be liable for criminal and civil action in addition to forfeiture of its performance security and denial of payment of bills.

General:

- 2. The actual requirement of area to be disinfecting may vary (increase or decrease). The bidder(s) shall be bound by the rates quoted by them to the National Highways & Infrastructure Development Corporation

 Limited.
- 3. Duly authorized representative of Bidders will be allowed to participate in the bidding process on production of authorization letter.
- 4. Staff deployed by the agency for carrying out the maintenance works should be trained in Disinfection/ Sanitization Spray work and should be of good conduct, should be physically fit for the work and should not be suffering from any chronic and contagious diseases or COVID 19 infection. NHIDCL shall not provide any personnel for the work.
- 5. None of the deployed staff should enter or remain in the NHIDCL premise beyond the specified time limits unless and absolutely necessary.
- 6. The Agency is to be liable for any damage caused to the NHIDCL premises or any part thereof or to any fixtures or fittings thereof or any property of the NHIDCL and therein by any act, omission, default or negligence of the Agency or its Staff.
- 7. Authorized Persons of NHIDCL shall monitor the work of the agency at regular intervals.
- 8. The Agency shall bear all taxes, rates, charges, levies or claims, whatsoever, as may be imposed by the Central Government or any local body or authority. The agency shall furnish such proof of payment of compliance or the obligations including registration certificates, receipts licenses, clearance certificates etc.
- 9. The Agency shall be solely responsible for compliance of all statutory provisions like payment of minimum wages to the personnel deployed, ESI, Insurance, PF, etc. Amendments made to these laws/ acts by the Central Government will be automatically applicable for compliance by the Service Provider without any separate sanction for the same.

- 10. The Agency is responsible for compliance to the provisions of various labour and industrial laws relating to the personnel deployed by it for the purpose or for any accident caused to them and NHIDCL shall not be liable to bear any expense in this regard.
- 11. NHIDCL shall not be held responsible for any statutory non-compliance on the part of the Agency with respect to the Labour Laws including PF, ESI, Workman Compensation, Insurance, Minimum Wages Act, Labour Safety, etc. or otherwise.
- 12. The Tax Deducted at Source (TDS) shall be deducted as per the provisions of the Income Tax Department, as amended from time to time and a certificate to this effect shall be provide to the agency by the National Highways & Infrastructure Development Corporation Limited.
