Minutes of Meeting

Empowered Technical Evaluation Committee (ETEC) met for "Restoration/Reconstruction of Ukhrul-Toloi-Tadubi road section from km 70.00 to Km 90.00 covering 20 Km length on NH-102A in the state of Manipur" held at NHIDCL, New Delhi on 15.03.2017- **Technical Evaluation-Reg.**

The RFPs for the subject work were invited with bid due date as **08.02.2017**.


2. During the meeting on **08.02.2017** committee ETBC opened technical bids in the presence of applicant's representatives who choose to attend and the hard copy of the original documents along with the soft copy (as received from E-bidding service portal viz. <https://eprocure.gov.in>) was handed over to the concerned Financial Consultants **M/s. PDMAG & Co.** for carrying out the evaluation of the Technical Bids. Details are as under:

3. The Financial Consultant of the package had submitted the preliminary technical evaluation report in respect of each bidder, based on the stipulated evaluation criteria mentioned in the RFP. In the preliminary report, Consultant had recommended certain clarifications to be sought from some of the bidders.

4. During the last meeting on 16.02.2017 committee (ETEC) recommended that the clarifications, required as per the recommendation of the Financial Consultant, be requested from **M/s Bhartia Infra Projects Ltd., M/s Vilelei Khamo and Sons and M/s Haokhotinlen Vaiphei** with due approval of the competent authority.

5. With the approval of Competent Authority, clarifications from the Applicant as suggested by the Financial Consultant were requested from **M/s Bhartia Infra Projects Ltd., M/s Vilelei Khamo and Sons and M/s Haokhotinlen Vaiphei**. Accordingly the replies to the queries submitted by the bidders and the recommendations of the Financial Consultant submitted on 15.03.2017 are as under:



6. **M/s. Shongvah Thanmi** is considered responsive in view of (MoRTH) letter, dated 16.01.2017 RW/NH-37010/4/2010/PIC-EAP (Printing). In accordance with the circular, the Bidder has submitted extended Bid Security valid up to 5th August 2017 vide email dated 15.03.2017.

7. **M/s Phongshi Phom** found non- responsive as submission of security deposit in form of Term deposit which should be in the form of Bank Guarantee/Demand Draft only (*ref Clause 16.2 of RFP*).

8. Accordingly, in view of the report submitted by Financial Consultant, Committee recommend that the bids of the four firms namely **M/s Bhartia Infra Projects Ltd., M/s Haokhotinlen Vaiphei, M/s Vilelei Khamo & Sons and M/s Shongvah Thanmimet** met the threshold technical and financial



capacity, are technically responsive in terms thereof. The Committee, therefore, recommended that the Financial Bid of the following Bidders be opened with the approval of the Competent Authority:

- (i) M/s Bhartia Infra Projects Ltd.
- (ii) M/s Haokhotinlen Vaiphei
- (iii) M/s Vilelei Khamo & Sons
- (iv) M/s Shongvah Thanmimet
