- 2. Following 2 (two) firms submitted their bids online on the CPP Portal and Infracon Portal for the subject project by due date and time.
- (i) Sterling Indo Tech Consultants Pvt. Ltd. in Association with Design Line Consultancy Services
- (ii) L N Malviya Infra Projects Pvt. Ltd.
- 3. The Committee observed that M/s L N Malviya Infra Projects Pvt. Ltd. (one of the responsive bidder) has been declared as the *most preferred bidder (H-1)* in the project "Consultancy services as Authority's Engineer for Supervision of "Upgradation to 2 lane with Paved shoulders of Tuivai-Keifang road, NH-102B of Aizawl-Imphal Economic Corridor from Existing Chainage Km 0.000 (Bridge across Tuivai River at Manipur Mizoram Border) to Km 119.108 (Near Keifang Village) [Design Chainage Km 0.000 to Km 98.579] (Package-I, II & III) in the State of Mizoram under Bharatmala Pariyojna on EPC mode". Accordingly, as per Clause 1.11 of RFP, M/s L N Malviya Infra Projects Pvt. Ltd. becomes ineligible for the financial opening as the bidder already has 03 (three) on-going projects in NHIDCL.

4. Therefore, since only a single bidder would be eligible for opening of financial bids and this being a first call, the committee recommended to annul the present bidding process and go for re-bidding, with approval of the Competent Authority.
