2.	Test of Responsiveness	Appendix IA, II & III	Name of the project is wrongly mentioned in Appendix IA, Appendix II & Appendix III submitted in the Bid. Please Clarify. In Appendix IA, pt. 6 & 19 are not as per the required format as per RFP. Please Clarify. In point 20 amount of Bank Guarantee is mentioned as 1.64 instead of 1.25 cr. Please Clarify.

Bid Capacity	Annex-VI to Appendix-1A (Bid capacity)	The Statement given by Statutory Auditor of bidder for certifying Value of B submitted do not certify the words " anticipated value of work to be completed in the period of construction of the project for which bid is invited " which are required as per Format of Annex-VI to Appendix-1A. Kindly provide the correct certificate duly incorporating the required statement by Statutory Auditor.

Technical Capacity	Annex-IV to Appendix-1A (Details of Eligible	The bidder has claimed project code A under category 1, however the equity shareholding certified by the Statutory Auditor for the eligible project is only up to commissioning of the project. Kindly provide the details of equity shareholding for the period for which experience has been claimed i.e., for the

		Projects)	<i>period from 01.04.2011 to 31.03.2016 and such details should be certified by the Statutory Auditor of the bidder.</i>

Technical Capacity	Annex-IV to Appendix-1A (Details of Eligible Projects)	<p>The Statutory Auditor certificates has been submitted by the bidder for projects claimed under category 3 or Category 4 related to Project Codes B to K. Technical Capacity	Annex-IV to Appendix-1A (Details of Eligible Projects)	<p>The bidder claims for Project code b that the work has been substantially completed, however, no supporting documents has been submitted which established that more than 90% of the Value of work has been completed.</p> <p><i>Kindly provide the supporting documents / certificates which establish that more than 90% of value of work has been completed for project code b.</i></p>
7.	Financial Capacity	Annex-III	<p>The bidder has submitted the Annex-III, financial Capacity of the bidder but not as per Format provided in the RFP.</p> <p><i>Please Clarify.</i></p>
8.	Bank Guarantee	Appendix – II (Bank Guarantee for Bid Security)	<p>In the Bank Guarantee submitted by the bidder, point no. 14 and 15 as per format given under Appendix – II (Bank Guarantee for Bid Security) are not mentioned.</p> <p><i>Kindly clarify and provide the amendment while including the aforesaid missing clause.</i></p> <p>Amount of Bank Guarantee is different as per RFP.</p> <p><i>Please clarify.</i></p>
